### **Minutes**

Attendance - Jim Dotterer called the roll. All directors were present except the following: Bob Greenman and Rich Montecucco (both excused), Jim Greeves, Chris Moffet, Ron Morton, Jerry Rheault and Bill Wright.

Treasurer's Report - The Treasurer reported the following balances: checking - \$789.57; emergency fund - \$2,363.54; capital projects fund - \$3,309.23 and money market account - \$84,232.61. Also, all bills were reported as paid including property insurance of \$1,5555.46. Dues and cowboy action moneys of approximately \$2,000 will be deposited 6/6/05.

Membership - In Rich Montecucco's absence, Jim Dotterer reported total membership remains about 400.

Funding Repairs/Clubhouse and Roads - To replenish club funds, Jim D. proposed that CCRP plan on logging as soon as the law allows, that is in 2006. Jim noted that CCRP could log this year provided it did not receive the proceeds from any logging until 2006. Darrell Gehlsen pointed out that the club needs to log the alders and any other trees that are failing. Jim D. discussed the prospect of hiring a professional forester (P.F.) to cruise club timber before any is harvested and then audit the cut afterwards. Mike Iyall volunteered to furnish Jim with the name of a P.F. who has worked for his family. Bob Gietz agreed that a P.F. should be retained. He suggested that the club establish a committee to hire a P.F. and logger. He suggested that the club talk to the former DNR employee who, while still working for the state, had surveyed CCRP property. He is now in business for himself. Will Ulry asked what trees would be cut and Jim D. outlined where they are located. Bob Jamison pointed out that certain trees, especially near the archery range have root rot and that these need to be logged. Mike I. said that the P.F. could tell us how much to harvest. Ray Crisp was concerned that if we repair the entrance road, subsequent log truck use could ruin the repairs. Jim D. suggested that Bill Vogel, Jim Hutson, Mike Iyall and himself form the committee.

Clubhouse Insurance - Jim D. indicated that an insurance agent had contacted him saying that the \$100,000 clubhouse insurance policy was inadequate and that about four times as much is needed. John Cadoo will contact the agent to get his/her opinion as to how much coverage the club should have.

Clubhouse Roofing - Jim D. reported that it is now apparent that having club members on the roof would be too dangerous. He will ask roofers for bids where the roofer performs all the work except disposal of the old shingles. However, other clubhouse work remains to be done such as pressure washing, painting, etc. Will Ulry noted that Thurston County will allow a land owner to dump up to fifty yards of debris on the property. Extensive discussion followed as to various alternative methods for reroofing the club house. Following this discussion, a motion was made to go back to the roofers for rebids. This motion was seconded and passed.

Roadwork - Bob G. outlined the work that needs to be done to repair the entrance road and described the three bids that have been received. Following considerable discussion, a motion was made to accept the bid from Everson Asphalt Paving for subgrade reconstruction, placement of a three inch layer of hot melt asphalt including placement of culverts and protecting the slope against any culvert outflow with a \$10,000 upper limit on the work.

Herb Turner has volunteered to regrade and repair club internal (dirt) roads. A motion was made that Herb be authorized to spend up to \$1.500 for equipment and gravel to make these repairs. The motion was seconded and passed.

Work Details - Jim D. outlined the work details proposed for the weekend of July 11& 12. They included: patrol the fence line to restore any downed fencing: brush the roads (Jeff Young); clean the highway sign (Will Ulry); power wash and repair exterior clubhouse panels; remove moss from black powder firing point roof (Steve Andrews); repair/replace the hi-power firing point roll roofing (Rick Baldwin).

Standing Rules -Shirley Rheault presented the final three sections of the S.R. and the Event Revenue Report form. The Match Operations, Introduction and Club Operations sections were approved. It was moved, seconded and passed that the Event Revenue Report be accepted as named. Issues regarding the Incident Report and the "additional access cards" items were tabled.

Tractor Front Loader - Ray C. questioned where the front loader needed to be taken to be sold. He volunteered to haul the unit to the



He reported TPD's investigations included seizure of CCRP's computer which was stored at the bookkeeper's home as well as various CCRP accounting records. He cautioned board members not to attempt to contact either our former Treasurer or bookkeeper at present regarding these investigations. Jim asked that directors approve appointment of John Cadoo to act as Treasurer temporarily in addition to his responsibilities as Secretary. A motion was made, seconded and passed that John be Treasurer temporarily. Jim previously had distributed Karen Halpern's

retary. A motion was made, seconded and passed that John be Treasurer temporarily. Jim previously had distributed Karen Halpern' resume. He asked that the board approve her appointment as CCRP's bookkeeper. Her appointment was moved, seconded and passed. She will be compensated at the rate of \$3.00 per member.

Recapturing Club Data and Records - Jim D. asked for a committee to visit TPD about 6/14/05 to recapture data from the club's computer. It's his understanding that TPD will allow the club to download certain data from the computer but, for the present, will not release the club's computer. In further discussions, Jim D. acknowledged that he didn't know if any CCRP funds were actually missing but, would be following up on this as more information became available. Bob Gietz pointed out that CCRP accounting practices had grown quite casual and asked that, in the future, a record of all receipts and disbursements be made available, on a monthly basis, to directors. Several directors suggested that not only the Treasurer but, also the bookkeeper should be bonded. Ray Crisp volunteered to find out how much bonding will cost the club.

#### **Safety First**

Many of our members who are new to the club's location, as well as anyone else that may depart the club driveway should use extreme caution when turning left or right on to Littlerock road. The main road curves in both directions and vehicles on the road usually travel at high rates of speed and are difficult to see. Turning right (North), can be especially dangerous if a car is passing another car, when both are traveling south. It is difficult to move forward so that you can see both lanes.

It is wise to drive at the posted club speed limits and use your headlights when negotiating the club's narrow roads. In addition to countless deer crossing the roads, other vehicles, traveling in both directions, are usually dodging chuck holes and negotiating tight curves and can appear out of nowhere. Also, the curve at the top of our road prior to the intersection, is a great place to lay on the horn. G.Reichelderfer
