Washington Historical Gunmaker's Guild

The Guild's conclave took place Aug 25th thru 28th at CCRP. Approximately 35 participants from novice to expert gunmaker attended. There was a large display of their work with some original guns and equipment. It was something to see; some real art work. These worthy competitors use a gun that they have built themselves in a competition to [win](#) the honor of making the trophy for the next event. Last year's winner was Dave Rase from Bremerton who framed a lithograph from the Dupont collection of historic powder labels. This year's Winner: Lee Kershner from Spokane. The adjacent photograph was an exhibit of historically correct reproduction of early American Arms brought by the featured speaker: Jack Brooks of Englewood Colorado. These items reflect the master craftsmen's ability to preserve and perpetuate the traditions. About 35 attendants listened to Jack Brooks presentation on construction historically correct pistols. In addition to the lecture presentations there were opportunities to gain hands-on skills in wood and metal working, study project design and layout, and observe techniques of casting and metal fabrication. Over 80 guns were on display, with an estimated net value of over \$100,000. MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

NRA membership (required)

Orientation class (required)

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)

Minutes

Capitol City Rifle & Pistol Club
Board of Directors Meeting
September 9, 2005

Meeting began at 7:02 PM

Flag Salute - Steve Andrews led the flag salute.

Attendance - All directors were present except the following: Rick Baldwin, Ray Crisp, Mike Iyall, Jerry Rheault, Will Ulry and Bill Wright. Jeff Young has been relocated by the U.S. Army to Germany.

Documents Received - A flyer for the public and one for members advertising the "Shooting, Hunting and Sporting Goods" garage sale scheduled, concurrently with the annual hunting sight-in days, October 1-2; letter of thanks received from the Washington Historical Gunmakers Guild. Drafts of a revised Incident/Accident Report Form; two-page description of CCRP organization, activities, range director contacts, match descriptions and firearms safety rules; CCRP Profit and Loss Statement and Balance Sheet as of September 3, 2005.

Treasurer's Report - Darrell Gehlsen reported the following balances: Capital projects: \$4,550.24; Checking: \$5,913.62; Emergency: \$2,924.22; Total Heritage Account: \$13,388.08; Total Homestreet account: \$80,630.86.

Membership - Rich Montecucco reported that there are 391 members.

Critical Area Meeting - Jim Dotterer reported that he had attended the Critical Area Meeting conducted at the Thurston County Fairground. He said that approximately 600 people attended, that another meeting will be held on September 27 and that the Thurston County Commissioners will review the results of these meetings. There was general discussion on the possible impacts of any ordinance that the commissioners might enact particularly since CCRP land encompasses or borders wet lands. However, in general, Jim suggested that impacts were not as threatening as first thought.

Washington Historical Gunmakers Guild - Bob Gietz reported that the Guild's meeting was a success; at one point historical firearms with an estimated value totaling \$100,000 were on display. The Guild wants to use CCRP facilities again, has submitted an Application for next year and has requested storage space on CCRP grounds to hold display equipment and shelves. Those attending were from Washington as well as surrounding states.

Road Report - Bob G. reported that repair of the entry road was almost complete and Darrell G. noted that the contractor has received final payment.

Range Safety Officer Class - John Mickel will teach a class on October 8th. Class size will be limited to seven individuals.

Liability Insurance - Jim D. noted that CCRP's liability insurance policy is good through April 2006. Policy is with Northland Insurance, the broker is Lockton Affinity. The broker has stated that it would "prefer" that members not bring guests. There was considerable discussion about the "guest" issue. Bob Jamison suggested that CCRP contact Duncan & Duncan. John Cadoo reported that Duncan & Duncan had contacted him regarding a possible visit to CCRP premises but, there had been no follow-up. He also noted that Sunset Insurance, CCRP's current fire insurance broker, might be able to arrange liability coverage.

Federal Income Tax - Jim D. reported that Parkside, CCRP's CPA, had contacted the IRS to request a copy of the club's 2003 tax return and expects a 60 day delay to obtain it. As a result of filing a request for extension, the CPA says the club has until November to file a return for 2004.

Clubhouse Door - Jim D. reported that Darrell G. had installed a new door. Darrell said that the combination was not changed.

Metal Door for Clubhouse Range - Jim D. and Bob G. obtained and transported to the clubhouse a (free!) 16 foot metal door. Jim is seeking volunteers to provide the expertise needed to identify and obtain the services of a contractor to install the door. The principal reason for installing the new door is to protect people/cars in the clubhouse parking lot.

Ex-Bookkeeper Status - Jim D. contacted the Thurston County Prosecuting Attorney. The PA indicated that a hearing will be conducted on 12/4/05. The PA doesn't believe that it will go to trial. Instead he expects them to "plea out."

September's "Women on Target" - Shirley Rheault reported that 52 people were registered for September 10-11. She also indicated that following the shoot, the club's revolvers will be returned to the clubhouse gun safe.

Hunter Sight-In - Jim D. indicated that Rick Baldwin had reported that he had enough volunteers to run the October 1-2 Hunter Sight-In.

Waive Assessment - Jeff Young has been transferred by the U.S. Army to Germany. He has indicated that he wants to remain a member and will keep up his dues payments while in Germany. It was moved, seconded and passed that CCRP waive his assessments during this 3-year period.

CCRP/CCB Agreement - Jim D. read a draft of a proposed agreement between the two clubs. The committee will review the draft, forward it to our legal counsel for further possible revision and then bring it before the CCB and CCRP boards.

Hiring a Forester - Jim D. indicated that he had only received the name of one forester as a possible hire for planning CCRP's 2006 harvest. After considerable discussion, Chris Moffet volunteered to seek the names of additional foresters.

Household Memberships - Darrell G. described his proposal for household memberships. In principal, it would apply to any group of people, regardless of their relationships, who live at the same address and are 18 years of age or older. All would be voting members. One would pay normal dues and initiation fee and each of the others would pay reduced dues, \$35/year and their initiation fees would be waived. His proposal would not apply to Capitol City Junior Rifle Club members. All participants in a household membership would be required to: be NRA members, attend orientation

classes, complete their annual 8 hours of club work or pay the corresponding assessment and have gate cards and each pay the \$10 gate card deposit. Darrell's proposal was moved, seconded and passed.

Scheduling Duties Reassigned - Jim D. announced that he had appointed Doug Simpson as club Scheduler.

Danger Tree Task Force - Jim D. proposed and asked for volunteers to man a "danger tree" task force. At present there are three trees threatening the club house parking lot. These should be removed before October 1.

"Garage" Sale - Bob G. announced a "garage" sale to be conducted concurrently with the Hunter Sight-In, October 1-2 in the indoor range. Shooting, hunting and sporting goods may be displayed on tables by members starting at 7:00 am on Saturday, October 1, one table per member, first come first served. There will be no fee for display or offering. Firearms may be offered by printed handouts for private sale off CCRP premises. Unsold items must be removed by 5:00 PM Sunday, October 2 or become CCRP property. Members will be responsible for pricing, negotiation and security of their items.

Incident/Accident Report - Shirley R. presented drafts of three different Incident/Accident reporting forms. It was moved, seconded and passed that version #2, similar to that previously used, be adopted and incorporated into the Standing rules.

Repair of Club Brush Hog - Bob Fenno volunteered to repair the club's brush hog and was provided with a \$300 budget for materials. His work will constitute payment of his membership dues and assessment credit for one year.

Troy-Bilt Mower - Jim D. noted that a Troy-Bilt walk behind mower was available to the club for \$800. It was moved, seconded and passed that the club purchase the mower.

Nominating Members for 2006 BOD - Chris M. requested that members interested in joining the 2006 Board of Directors contact him. Darrell G. volunteered to run for Treasurer. John C. indicated that he would not seek the Secretary's position again.

Adjournment - The meeting adjourned at 9:10 PM
