MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)

Minutes

Capitol City Rifle & Pistol Club
Board of Directors Meeting and
Annual General Meeting
December 2, 2005

Meeting began at 7:00 PM

Flag Salute - Rich Montecucco led the flag salute.

Documents Received - Darrell Gehlsen - CCRP Balance Sheet as November 30, 2005 and Profit & Loss Statements for November 2005 and January through November 2005.

Attendance - All directors were present except the following: Mike Iyall, Ron Morton, Noel Vaughn, Bill Wright, Jim Greeves and Jim Zobrist.

Treasurer's Report - Darrell Gehlsen reported the following balances: Heritage Bank checking: \$4,029.36, Homestreet Bank checking: \$74,939.96 and Homestreet certificates of deposit: \$20,000. Net income for November -\$2,355.27.

Membership - Darrell G. reported that there are 417 members. Rich Montecucco indicated that CCRP's participation in local gun shows has been a real asset to increasing club membership. Larry Lufkin suggested that the club contact former members to encourage them to return to the club. Jerry Rheault said that when he was President the club had tried contacting former members and that it didn't produce significant results. Rich M. circulated a scrapbook of club photographs prepared by his wife, Peggy. It was clear to all who viewed it that she had done an outstanding job.

Federal Taxes - Jim Dotterer reported that the 2001 and 2002 taxes were filed late and that currently, the IRS is refusing to provide a copy of the club's 2003 tax return. The club's CPA is attempting to obtain a copy pursuant to correcting it and preparing the club's 2004 return.

Former Accountant - Although no firm figure can be determined, Jim D. said it appears that the club's former accountant took about \$80,000 of club money. Jim pointed out that Darrell Gehlsen had already spent 180 hours of his time in correcting the club's accounts and that he had spent 200 hours for a total of 380 hours.

CCB/CCRP Lease Agreement - Jim D. announced that a proposed agreement containing a lease between CCB and CCRP had been drafted. The purpose of the lease is to recognize that CCB and CCRP, for tax purposes, are separate entities. When signed, the lease will apply to approximately 39 acres of CCRP property that now contains CCB facilities. The lease will be forwarded to Hank McCleary for his review. The lease cost to CCB will be \$1 per year plus a standard range fee for each individual participating in CCB events. Jerry Rheault asked which club would be responsible for maintenance of facilities within the leasehold and suggested that this matter be covered in the agreement. Jim D. assured him that CCRP will continue to maintain the roads that pass through the leasehold and further pointed out that the lease can be canceled by either party giving suitable notice. Rick Baldwin pointed out that for some members, a 600 yard hi-power range would be highly desirable and that such might cut off a corner of the leased area. Several members suggested that the longer range would be highly desirable but, Ray Crisp pointed out that until funds to construct such a range are available this would not be an issue.

Big Buck Contest/Potluck - Will Ulry announced that the annual contest/potluck was scheduled for January 18th. Those whose trophies (Elk, Buck, Washington Buck, etc.) come out on top will have their names added to the plaque. However, the real purpose of the event is to foster club fellowship.

Rain-Dee-Voos - Bob Gietz announced that the sale of raffle tickets for the muzzle loading rifles and sale of the Lewis and Clark Medallions was underway. He assured the directors that sale of the raffle tickets will be fully compliant with the requirements of the Washington State Gambling Commission. Also, any club member who wishes to market raffle tickets should contact him. Bob asked that the club front the money needed to prepare for Rain-Dee-Voos. It was moved, seconded and passed that Bob receive \$1,000 to make preparations for the event.

April/May Scout Event - Bob G. pointed out that November's Scout event had proved very popular and that an application for a grant to conduct another Scout event in April or May had been submitted to the Washington Muzzle Loader's Association.

National Archery Shoot - Ray C. discussed preparations for the national archery shoot to be conducted over the Memorial Day weekend in 2006. He expressed concern over two elements in the draft agreement proposed by Reinhart 3-D, the prime sponsor. These elements are: a) that any legal action resulting from the conduct of the event is conducted in the courts of the State of Wisconsin and b) that should CCRP fail to provide "adequate help" in conducting the event that the gate split be reduced from 20% for the club to 10%. He said that both of these concerns would be addressed in any final agreement. Ray said that the number of participants will be in the range of 400 to 600 and that adjacent property owners be encouraged to offer their property for a fee as parking space. Considerable discussion followed over possible CCRP liability that might grow out of the event. Ray assured directors that CCB's liability policy would cover the event. He also said that 12 to 15 club members will be needed to staff the event and that each participant will spend an average of \$30 as an entry fee. Rich M. asked that Hank McCleary be asked to review the agreement. Whether or not the club should operate a kitchen to feed participants or arrange for the event to be catered was also discussed. No conclusion was reached.

Fire Insurance Coverages - John Cadoo requested that the various Range Directors present any needed revisions to the structure or content values assigned to their respective ranges. After considerable discussion, it was determined that there are three structures on the Action Pistol Range. The values assigned to the respective structures and their con-

tents were as follows: structure one, value \$6,000, contents \$20,000; structure two, value \$3,000, contents zero (it's empty) and structure three, value \$3,000, contents \$2,000. The tractor shed value of \$30,000 was not changed but, the content value was estimated to be \$3,000. John indicated that he would take these changes to Sunset Insurance.

Surplus Gear - Bob Greenman listed a number of items stored in the upper levels of the club house. If nobody had a use for them, he wanted to dispose of them. The BOD gave him directions as to what to trash.

Annual Work Weekend - Shirley Rheault reminded the Board that at the August 5th meeting a single summer work weekend (as opposed to two weekends) was approved and also it was approved that it be scheduled for the fifth weekend of either July or August so as not to disrupt regularly scheduled matches. She distributed a schedule of 5th weekends for the years 2006 through 2030.

WAC Article on CCRP - Shirley R. announced that the January issue of the Washington Arms Collector newsletter would include an article on CCRP.

Danger Tree/Firewood Task Force - Jim D. reminded the Board that a tree, on the Action Pistol Range, did fall on one of the structures but, did not inflict serious damage. He asked for volunteers to drop other danger trees and cut them into cord wood. Jim and Ray C. both volunteered.

Waiver Request - Without specifying names, Jim D. announced that a couple fighting cancer had requested a waiver of their assessment. The request was referred to the Executive Board. The request was granted by the Executive board. Larry Lufkin said that the Board of Directors should be informed as to who was making the request. Jim denied his request.

Revised New Member Orientation - Bob G. outlined a change in the focus of the New Member Orientation class. Because of an apparent need to achieve compliance on the Hi-Power Range with club procedures, the NMO class will shift its focus from the Action Pistol Range to the Hi-Power Range.

Non-Member Range Usage - Bob G. pointed out a potential problem when matches are conducted and the main gate is locked open. In his opinion, passers-by on Littlerock Road see the main gate open and enter to use ranges other than those where the matches are scheduled. He suggested that the discipline that is conducting the scheduled match station a member at the top of the hill to check incoming shooters for membership. Ray C. suggested that this be done on a trial basis. Larry Lufkin suggested that non-member visitors headed for other than the scheduled match be charged a fee. No decision was reached.

Clubhouse Overhead Door - Will U. reported that he had contacted three contractors about installing an overhead door in the entrance to the clubhouse range. In general, the contractors contacted did not want to attempt installation of the used door acquired by the club earlier. Ron Lohman pointed out the potential danger of having an arrow pierce a single panel overhead door. Others pointed out that plywood shields on rollers could be placed behind the archery targets. Darrell G. said that the capital account had sufficient funds to have a contractor install a first class door. Bob G. said that the club should install the largest standard sized door available. Will U. will contact the contractors again to get pricing.

Action Pistol Range - Rich M. asserted that there is a great deal of resentment generated by the requirement that members complete a separate class in order to acquire a key to the Action Pistol Range. He suggested that the membership be polled to determine their wishes with regard to such classes. No action was taken.

Recess

Annual Meeting - Following a brief recess, Jim D. called the annual meeting to order, and as required, turned the meeting over to the Chairman of the Nominating Committee, Chris Moffet. To initiate the Annual General Meeting, Chris asked if those present wanted to vote on each individual or the complete slate of nominees. It was evident that those in attendance wished to vote on the complete slate. The vote was taken and all those nominated were elected.

Appointments - Chris M. reconvened the BOD meeting. All existing directors will continue in office except Jim Zobrist and John Cadoo. Members of the new Executive Board include Chris M., President; Jim D., Vice-President; Greg Squires, Secretary; Darrell G., Treasurer; Will U., Safety Officer; and Bob G., Training Officer. Larry Lufkin will assume responsibility for Hunter's Ed and Ron Lohman was appointed Multi-Purpose Range Director. As he turned over the gavel to Chris M., Jim D. asked that directors inform Shirley R. of any changes to their contact information.

Directors Terms of Office - Terms expiring 12/31/06: (six): Squires, Andrews, Morton, Ulry and S. Rheault; terms expiring 12/31/07 (seven): Greenman, Greeves, Mofett, Crisp, Baldwin, Wright and Montecucco; terms expiring 12/31/08 (seven) Vaughn, Simpson, Gehlsen, Dotterer, Lufkin, Gietz and Lohman.

Adjournment - The meeting adjourned at 9:20 PM. As I leave the BOD, I want to thank all those members who have taken the time to correct the many errors I've made in recording the minutes over the past four years. I've really appreciated your help.

State Awards \$6 Million in Grants for Recreation Projects

OLYMPIA - Projects in 24 counties will receive funding totaling more than \$6 million to improve trails, boating facilities and **firearm and archery ranges** in Washington, the Interagency Committee for Outdoor Recreation announced today. The Interagency Committee is responsible for evaluating proposals and distributing funding for nine grant programs. In all, the agency received 100 proposals requesting more than \$12 million in funding under three grant programs. The committee was able to meet only about half that demand because of limited funding.

"Washington has a great variety of places to recreate, whether you like to go boating, hike a trail, or practice archery," said Laura Johnson, director of the Office of the Interagency Committee for Outdoor Recreation. "These grants play a vital role in keeping those opportunities available. They do everything from building new trails to adding lanes at a boat launch. They help us maintain what we have and add new elements to accommodate increased use."
