Safety Issue

I have a report by a member that spent a good share of a day on the High Power Range. He says that several times during the day shooters were handling firearms while other shooters were down range. This is completely unacceptable. Myself and our present Training Officer Bob Geitz carefully outline this to new members. The only way you can handle firearms is cased. This means no moving, adjusting, or touching and that is real clear. There shouldn't be a remote question on this subject. Bob reported at the last meeting that he has "Trained" 200 new members since he started as Training Officer. This means at least half of the current membership has been told. You need to be vocal on this subject. Remind violators of the rule. If there is shooting going on when you arrive shooters expect that fellow members will be handling firearms. When the line has been secured and members are down range they should expect a safe environment. Many of us that have done Hunters Sight In know firearms show up loaded with actual rounds chambered. Everybody doesn't do this but why take a chance. Obey the range rules. "BE SAFE".

MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)

CAPITOL CITY RIFLE AND PISTOL CLUB**BOARD OF DIRECTORS MEETING****Sept. 8, 2006**

The meeting was called to order at 7:05 PM

Flag Salute: Chris Moffitt led the flag salute

Attendance: All board members present except: Jim Greeves. Members excused were Bob Gietz, Bill Wright, Bob Parr, Will Ulry, Ray Crisp, Shirley Rheault & Rich Montecucco.

Treasurer's Report: Darrell Gehlsen reported the following balances; Homestreet \$22,349.64, Certificates of Deposit \$81,519.50 and checking \$4,659.54. Darrell also reported that the club year to date net income is 17,770.83. Darrell also reported that our accountant had filed for another extension on filing our 2005 federal tax. We need to find out why an extension is needed and also how much it will cost the club. In addition, the tax status of the club is still not settled. Jim D. made a motion to accept the treasurer's report, Rick. seconded, motion passed.

Membership Report: Darrell reported that the club has 417 members at the present time.

Old Business

Retiring Directors: A few of the current members of the Board will be completing their terms at the end of the year. The members discussed forming a nominating committee and also discussed whether all of the anticipated vacant positions that will come up actually need to be filled. The By-laws allow for a minimum of 3 and a maximum of 30 board members. Anyone interested in serving on the Board can contact any of the executive officers and their name will be placed in the hopper.

Roof Bids: Bob Jamison reported that the required permits have been granted and the contractor will begin work in late September. Bill Dean spoke with the Board regarding removal of the old shingle and roofing materials. The club had originally planned to use the materials as fill for berm expansion. Bill, who works for Thurston Co. Health, noted that it may be illegal to dump solid waste in an area that is not designated as a waste site. He also noted that in the event we ever wanted to sell the property, having waste material buried on site could adversely affect that process. It will cost approximately \$4,000.00 to remove the material to an approved dump site. Bob J. will contact the County and ask them to provide dumpsters for W/M removal. An E-Board meeting will be held to approve the cost once all factors are known.

Timber Management: The timber management plan has been signed and returned to the timber manager.

Long Range Planning: Items mentioned to be added to the long range planning process were: Upgrade electrical wiring in clubhouse, add power to all ranges, add pumpable toilets rather than portables, construct sound barriers on property perimeter, increase parking at blackpowder and action pistol ranges, develop a general maintenance fund and move entry gate down to Littlerock Rd. Also, move pistol bay at high power range 90 degrees for safety reasons.

New Business

2007 Budget: All range directors need to develop their budgets for the upcoming year. If a budget is not developed, the Board will spend your money. In the words of Larry the Cable Guy, GIT-R-DONE.

Gate/Land Ownership: Jim D. has found the original, signed, memorandum of understanding related to the land swap that gives us the property below the gate. The documents will be taken to the parties involved and then, hopefully re-recorded with the county. After filing, the club can deal with moving the entry gate down the hill to Littlerock road.

Range Status: Jim D. reported that all range permits are current. Some of the county records show the official name of the club as Capital City Rifle and Skeet. Jim will take the appropriate measures to make sure all documents show us as Capital City Rifle and Pistol.

Member Orientation: Bob Gietz has suggested that the schedule for new member orientation presentations be changed. We currently do 16 sessions, but many are very light on attendance. The proposed schedule is as follows: The first Wednesday of each calendar quarter and approximately six weeks later on the first Saturday of the month. Proposed dates for 2007 are 1/10, 3/3, 4/11, 6/2, 7/11, 9/8, 10/10 and 12/1.

Women on Target: Events are planned for September 23rd and 24th. Both events are short on help so if you can, please contact Shirley Rheault and lend a hand. It is a worthwhile event and gives the club a lot of good press.

Hunter Education: The teaching team affiliated with CCR&P is looking for people interested in becoming certified instructors. If you are willing to make the commitment, contact Chris, Will or Greg for more information.

Motion to Adjourn: Jim D. made a motion to adjourn at 8:30 PM. Noel V. seconded. Motion carried.

BLACK POWDER COMING SOON

Black Powder Muzzle Loading monthly matches will resume on Sunday, October 15th. At the usual time (Shooting start at 1000) and accustomed location (The Black Powder Range, naturally). A few words of information for prospective new participants: Matches are shot in open relays with new shooters able to join the match in progress if there are situations delaying arrival. Each match includes events for Rifle and Pistol, and usually, Trade Gun. Match range fee is \$10.00. Targets include paper and reaction targets with flyers for the Trade Gunners. Prizes, provided from the Range Fees are given for the top three in each category Aggregate blanket prizes are awarded to those with the best combined scores of combined rifle and pistol. Suggested aggregate prize (approx. \$5 value) is something period related (or, typically a miniature Abraham Lincoln commemorative poster which looks very much like a \$5 bill). Aggregate scores are computed and posted in order but those contributing to the blanket are given the opportunity to recoup something for their efforts

The November match will be our traditional Turkey Shoot which will have blanket items (Turkey, Ham, Bacon) provided by the free Trappers.

Match Dates for the coming season are: October 15th, November 19th, December 17th, January 21st, April 15th, May 20th (No matches in February or March due to Rain Dee Voo and Spring Thaw events)

Each match will offer one or more additional luck targets. Traditional, 'period attire' is optional , will be recognized for bonus points for three clothing items and for moccasins or true period foot wear.

In preparation for Rain Dee Voo 2007, a brief Free Trappers meeting will be held at each shoot. Raffle tickets for the rifle are available. Spectators and new shooters are welcome. Have eye and ear protection available and you'll probably have a chance to try your hand. Advice or additional information is available from:
