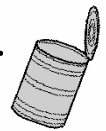

An added attraction is that on the second day of the Northwest Regionals (9 Sept), which is the 50 meter portion, is also included in the World Rimfire Benchrest Championship. Every competitor will be included in world standings. In addition, all 14 countries participating in the world event will have three 3man teams from each country. The 3 US teams will compete during regular national and regional matches in either Penn, South Carolina, or here at CCRP!! This will be the 1st time that our local shooters will be able to participate in a major benchrest match without extensive air travel and they are looking forward to it.

## **Action Pistol Range**

Just what is the action pistol range? This range is primarily a hand gun and cowboy action match range. Behind the locked gate is basically bays and gravel. There are no fixed firing lines nor target stands or targets as there in other CCR&P ranges.

Who primarily uses this range? Pistol match competitors come to this range to practice. What do they practice that is not normal for the Multi Purpose range? Several of the hand gun sports require drawing a pistol, acquiring a target or targets and shooting in a tight time frame. The distances for the targets are rather close in many cases.

How do I earn a key to this range? You can call Jim Dotterer 360-412-8229 or email him at [dottej@comcast.net](mailto:dottej@comcast.net). You will need to download the A P rules booklet and the AP test. Go to the CCRP web site, click on documents, upper left is navigation click on ranges and you will be able to download and print the booklet and the test. After you have completed the test, contact Jim for your gun handling and safety evaluation. This will take about 3 hours, you will be required to help set up and tear down the ranges.

#### **MEMBERSHIP DUES RATES**

*Dues and Renewal policies are effective September 1, 2003*

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

**(GUESTS:** Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)

**HOW THINGS HAVE CHANGED** by Jim Bice

Last Wednesday, June 6th marked the 63rd anniversary of the D-Day invasion of Normandy during World War II. This was the major culminating event that led to the freeing of Europe from the grasp of Nazi Germany. The Nazis, under Adolph Hitler, had killed millions of people and would have continued to do so if the United States had not entered the war.

Remember, Germany never attacked the United States. The war lasted over four years and we lost hundreds of thousands of our military personnel. During the course of the war many mistakes were made in strategy and battle plans. We continued to occupy Germany and much of Europe for over 50 years after the war. Our military personnel were subjected to attacks from insurgent groups for over ten years after the war was ended.

President Franklin D. Roosevelt offered this prayer the following day:

"My Fellow Americans:

Last night, when I spoke with you about the fall of Rome, I knew at that moment that troops of the United States and our Allies were crossing the Channel in another and greater operation. It has come to pass with success thus far.

And so, in this poignant hour, I ask you to join with me in prayer:

Almighty God: Our sons, pride of our nation, this day have set upon a mighty endeavor, a struggle to preserve our Republic, our religion, and our civilization, and to set free a suffering humanity.

Lead them straight and true; give strength to their arms, stoutness to their hearts, steadfastness in their faith.

They will need Thy blessings. Their road will be long and hard. For the enemy is strong. He may hurl back our forces. Success may not come with rushing speed, but we shall return again and again; and we know that by Thy grace, and by the righteousness of our cause, our sons will triumph. They will be sore tried, by night and by day, without rest -- until the victory is won. The darkness will be rent by noise and flame. Men's souls will be shaken with the violences of war.

For these men are lately drawn from the ways of peace. They fight not for the lust of conquest. They fight to end conquest. They fight to liberate. They fight to let justice arise, and tolerance and goodwill among all Thy people. They yearn but for the end of battle, for their return to the haven of home.

Some will never return. Embrace these, Father, and receive them, Thy heroic servants, into Thy kingdom.

And for us at home -- fathers, mothers, children, wives, sisters, and brothers of brave men overseas, whose thoughts and prayers are ever with them -- help us, Almighty God, to rededicate ourselves in renewed faith in Thee in this hour of great sacrifice.

Many people have urged that I call the nation into a single day of special prayer. But because the road is long and the desire is great, I ask that our people devote themselves in a continuance of prayer. As we rise to each new day, and again when each day is spent, let words of prayer be on our lips, invoking Thy help to our efforts.

Give us strength, too - strength in our daily tasks, to redouble the contributions we make in the physical and the material support of our armed forces.

And let our hearts be stout, to wait out the long travail, to bear sorrows that may come, to impart our courage unto our sons wheresoever they may be.

And, O Lord, give us faith. Give us faith in Thee; faith in our sons; faith in each other; faith in our united crusade. Let not the keenness of our spirit ever be dulled. Let not the impacts of temporary events, of temporal matters of but fleeting moment - let not these deter us in our unconquerable purpose.

With Thy blessing, we shall prevail over the unholy forces of our enemy. Help us to conquer the apostles of greed and racial arrogances. Lead us to the saving of our country, and with our sister nations into a world unity that will spell a sure peace -- a peace invulnerable to the schemings of unworthy men. And a peace that will let all of men live in freedom, reaping the just rewards of their honest toil.

Thy will be done, Almighty God.

Amen."

America is now engaged in a war against an enemy every bit as dangerous and loathsome as was Hitler. We have made mistakes, as was the case in WW II. Our troops are under attack by insurgents and we will likely need to continue to keep a military presence in the area for years to come. **(A) Club house power panel**

**Brief Description:** Replace Power panel in kitchen and add capacity

**(B) Entry gate relocation**

**Brief Description:** Relocate entry gate to more desirable location after clearing legal title issues

**(C) Black Powder Range Safety Berms**

**Brief Description:** Raise and enlarge backstop area to more effectively control bullet impact. Would require tree clearance and supply of fill material. Consider combination with other actions.

**(D) Construct 600 yard High Power Range**

**Brief Description** Construct new range to allow shooting at extended ranges. Require plan and permit development

**(E) Informal Shotgun Range**

**Brief Description:** Range dedicated to shotgun use, informal scattergunning. For casual shooters

**(F) Action Pistol Enlargement**

**Brief Description** construct additional shooting bays on this range to increase range capacity. Accompanied by expansion of parking and access road improvement. Depending on design could facilitate other projects using fill

**(G) Loop road improvements**

**Brief Description** Improve road width from Action Pistol to "the wye" improving range access by two-way road. Also could include development of roadside parking near Action Pistol.

## Membership Dues and Assessments

There have been a few misunderstandings about dues and assessments.

Statements for dues and assessments are sent out about the middle of the month before they are due. The statement will list your annual dues for the coming year and your assessment for the past year. If you have worked for your assessment or recruited new members to offset your assessment you include your work card or the names of the members you recruited as payment for your assessment. If you send a payment that does not cover the full amount and no work card to cover the assessment your payment will be applied to the assessment first as it is for the previous year. If this happens I will try to contact you so your membership will not be lost.

If your dues are to be renewed in the month of June a statement will be sent out about the middle of May. In order to use work or recruitment to pay your assessment it has to be done before June. You will have about 45 days to pay your dues (from the middle of the month before until the end of the month they are due). All statements will show the due date as the first of the month but you have until the end of the month before you are late. We do not track birth-days or join days, only the month.

On about the first of the month following your due date your gate card will be turned off if you have not paid (July 1st in the above example). About the first of the next month your membership will be canceled and your gate card will be deleted from the system (August 1st in the example).

Once that happens you will have to go through the new members class and start all over including the initiation fee.
