USA Shooting Air Rifle Nationals

On July 9, 2007, the Capitol City Junior Rifle Club sent five of its members to Bowling Green, Kentucky to compete in the 2007 USA Shooting National Junior Olympic Three-Position Air Rifle Championship. The team members are Kyle Rebellion (Steilacoom), Josh Pagel (University Place), Danny Lowe (Littlerock), Dawson Morris (Tenino), and Jennifer Greeves (Lacey)

The team finished in 8th place out of 23 teams from across the nation and there were a total of 168 competitors. The shooters finished in the following order Kyle (20th), Danny (36th), Josh (69th), Dawson (82nd), and Jennifer (90th)

Three of the Capitol City junior shooters also participated in the NRA National Junior Air Gun Team Championship in Akron, Ohio the week before. Those shooters are Kyle (4th), Danny (23rd), and Josh (26th) out of 105 individual shooters. The state of Washington sent two teams, finishing 4th and 10th out of 24 teams.

We had 19 shooters and 28 guns for the match and had excellent weather for the October beginner/intermediate match. The match was conducted on bays 2 and 3 of the Action Pistol Range. It was cold in the morning but warmed up a lot by noon when we finished. We really turned the match on its ear this month with some weak and strong hand shooting as well as some precision shooting on a "bowling pin snake" which was shot from the stairs. We also had some long range shooting, including 2 stations with weak and strong -hand strings. One of the long range stations was shot from around the sides and through the windows of a barricade. All shooters indicated a clear desire to continue with type of match which stretched their abilities. The high score was only a 60. The lowest was an 18 although there were several scores in the 20s.

BLACK POWDER MONTHLY MATCHES

Black Powder Muzzle Loading monthly matches will resume on Saturday, October 6th. At the usual time (Shooting start at 1000) and accustomed location (The Black Powder Range, naturally). A few words of information for prospective new participants: Matches are shot in open relays with new shooters able to join the match in progress if there are situations delaying arrival. Each match includes events for Rifle and Pistol, and usually, Trade Gun. Match range fee is \$10.00. Targets include paper and reaction targets with flyers for the Trade Gunners. Prizes, provided from the Range Fees are given for the top three in each category Aggregate blanket prizes are awarded to those with the best combined scores of combined rifle and pistol. Suggested aggregate prize (approximate \$5 value) is something period related (or, typically a miniature Abraham Lincoln commemorative poster which looks very much like a \$5 bill). Aggregate scores are computed and posted in order but those contributing to the blanket are given the opportunity to recoup something for their efforts

The November match will be our traditional Turkey Shoot which will have blanket items (Turkey, Ham, Bacon) provided by the free Trappers.

Match Dates for the coming season are: October 6th, November 3rd, December 1st, January 5th, February 2nd, March 1st, April 5th, May 3rd.

Each match will offer one or more additional luck targets. Traditional, 'period attire' is optional, will be recognized for bonus points for three clothing items and for moccasins or true period foot wear.

In preparation for Rain Dee Voo 2008, a brief Free Trappers meeting will be held at each shoot. Raffle tickets for the rifle will be available starting in December. Spectators and new shooters are welcome. Have eye and ear protection available and you'll probably have a chance to try your hand. Advice or additional information is available from:

Capitol City Rifle and Pistol Club, Board of Directors Meeting Minutes

October 5, 2007

Chris Moffet called the meeting to order at 7:00 p.m. Rick Baldwin led the flag salute. Roll Call: Steve Andrews, Darrell Gehlsen, and Bob Greenman were excused. Ray Crisp, Rich Montecucco, and Ron Morton were absent. All other directors were present. Guests were Bob Jamison, Bill Steigner, Dale Gigstead, and Norm Mead.

Chris Moffet delivered the treasurer's report, Bob Geitz provided the motion to accept, 2nd by Ron Lohman, all passed.

Membership per Bob Gietz stands at about 460 to 470 members. Larry Lufkin volunteered to assist with the orientations.

Under Old Business:

Chris Moffet reported on the two meetings held in the last two weeks of September to discuss the Action Pistol Range rules. The following people attended the 9/18 meeting: Chris Moffet, Darrell Gehlsen, Bill Wright, Bob Geitz, Ron Lohman, Paul Steinman, Jim Dotterer, Bob Jamison, and Wyley Moore. The following attended the 9/24 meeting: Chris Moffet, Will Ulry, Bob Geitz, Bob Greenman, Wyley Moore, and Bill Wright. The net result of the two meetings is that no one was opposed to the rules and the recommendation is that the rules remain the same. Bill Wright made the following motion: After hearing the discussion at the two meetings to discuss the Action Pistol Range rules and hearing no objections, be it hereby resolved that the Action Pistol Range is operating in accordance with the Capitol City Rifle and Pistol Club Bylaws and Standing Rules and require no further discussion. 2nd by Will Ulry, all passed.

Bob Gietz reviewed the changes to the Development Plan and made a motion to adopt the plan as revised on 10/5/07 and refer to the membership for consideration and to be voted on at the annual meeting, 2nd by Paul Steinman, all passed. We want to thank Bob Geitz, Larry Lufkin, and Noel Vaughn for all their work on this.

Chris Moffet reported that there is no new information concerning the property/ gate situation. The documents are in the hands of the club attorney and he will let us know what is happening.

Chris Moffet reported that Mike Jackson of Professional Forestry Services will be sending a completed Forest Practices application to him in a week's time.

A committee was formed to complete the Range/ Match Rule Update. The chairperson nominated is Irene Hertwig (pending her approval). The committee members are the Range directors and their subcommittees are the match/ event directors that use those ranges. Note: Irene did accept the chair for this committee.

Under New Business:

Bob Gietz brought up a member's suggestion that a photo montage of the club's activities be created and displayed at the membership booths at the gun shows. Anyone interested in working on this, contact Bob Gietz.

Bob Gietz noted that the club woodshed is quite empty and there is an abundance of dead and downed trees on the property that could be cut to fill it. We are looking for volunteers.

Bob Gietz reported on the Blackpowder Trail work party. Our thanks to Bob, Doug Simpson, John Vladeff, Jim Robertson, Tim Sampson, Dave Perry, Dave Dolliver, Tony Yaklich, and Will Ulry for their work. Good Job, Men!

Bob Gietz reported that the replacement toilet units have arrived and are in place.

Chris Moffet had asked that the match and event directors be at the meeting to go over some details on paperwork. A few showed up. Chris noted that a waiver must be signed for each event by all attendees – member and non-member. That waiver can be turned in with the event report or a list of attendees, by name, can be attached to the report. An event is the whole thing i.e.: the Raindevous. A league needs the waivers for each separate event.

Chris Moffet reported on the Women on Target event for Shirley and Jerry Rheault. 100 students came through the classes with \$570.00 being submitted to the club. Shirley thanked the board for their support and Bob Jamison for his work on the score shed door. Good Job, Jerry and Shirley, and Thank You!

Chris Moffet appointed the nominating committee for the up and coming annual meeting and director election. Those people are: Paul Steinman, Bob Gietz, Dale Gigstead, Noel Vaughn, and Rick Baldwin. Thank you, gentlemen, for stepping up to this task. Members, these are the people to contact to let them know you are interested in serving on the board of CCR&P.

MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)
