Ten Free Trappers showed up on Saturday April 5th for the monthly shoot. Particularly we would like to welcome Rowland Zoller to the ranks as he joined in for his first participation. Couldn't have a report without a note as to the weather, which defied the forecast "sprinkles" and even had a few brief moments of sunshine. The event started of with the Free Trappers meeting and BO Brown went over his expectations for the new challenge as Booshway for Rain-Dee-Voo 2009. Steve Andrews, Range director showed off the WSMA Award plaque which was given out at the WMSA shindig on March 29th. Rain Dee Voo 2007 was voted #2 rendezvous event for the 2007 year and the plaque will be on display in the club house. Down to the shooting results. Meat prizes were the order of the day and Pistol awards went to Doug Simpson, 1st; Mike Nesbitt, 2nd; and Adam Sampson 3rd. Rifle: Steve Andrews 1st, Glen Sutt, 2nd; and Mike Nesbitt 3rd. Trade Gun: Don Kerr, 1st, Steve Andrews, 2nd; and Mike Nesbitt 3rd. Aggregate awards for those donating prizes were: 1st Mike Nesbitt; 2nd Steve Andrews; 3rd Glen Sutt; 4th Doug Simpson; 5th Don Kerr; 6th BO Brown; and 7th Tim Sampson. "Lucky Mike Nesbitt" took home both of the luck shoot prizes with a diplomatically negotiated tie-break with Tim Sampson on the Gopher head target. Reminder that the next monthly shoot will be Saturday May 3rd with aggregate prize donations required. That will be the final shoot until resuming in October.

## What is Field Target?

Field target is an airgun sport that is similar to an archery trail walk only it's done with airguns. Animal shapes are cut from mild steel and mounted on a hinged base that is staked to the ground at varying distances. A hole is drilled in each target (the kill zone) and behind the hole is a "trigger". Shooting thru' the hole and striking the trigger causes the animal to fall and the shooter scores one point. Since field target shooters are typically lazy, we attach strings to the targets so we can re-set them from the firing line. No need to walk down range.

Hole sizes vary from 1/4" to as much as 2" and the targets are placed from 10 to 55 yds away from the shooter. Positions are mostly optional with most people shooting from a sitting position. Usually we will have one or two lanes, out of 10, that will specify a position, such as standing or prone.

This is a "low key" type of match with shooters being squaded in groups of 3 or 4 individuals. Each lane will have 2 targets in it and the shooter will get 2 shots at each target. With ten lanes, that will make a 40 shot match. Matches last approximately 2 hours and shooters are divided into classes based upon the airgun and equipment they are shooting.

In our club, we have three different classes. One is PCP (Pre-Charged Pneumatic), Spring Gun, and Hunter class. Scopes are very desirable and many of the more advanced shooters will shoot scopes with power levels from 24X up to 40X. Hunter class is limited to 12X maximum. The 3-9X are very popular.

What equipment do you need to compete? An air rifle, at least 40 pellets, a scope (if you want to get serious), and something to sit on that is no more than 6" thick. There is a lot of equipment that a shooter can accumulate but you can compete with just the above list.

The one limitation is that your air gun must limited in power to less than 20 ftlbs. That is usually less than 950 fps in .177 caliber. We have people come out and shoot with Benjamins and people who shoot with imported German rifles. You can have fun with just about any air rifle you have. You must have a rifle that shoots lead pellets. No steel BB's are allowed.

Field target is overseen by AAFTA (American Airgun Field Target Ass'n) and there are rules to follow. As opposed to most organized sports, the AAFTA rules are minimal and deliberately so. John Mickel

#### <u>MEMBERSHIP DUES RATES</u> Dues and Renewal policies are effective September 1, 2003

### Do you need something to do to work off your assessment?

The electric gate cable needs to be reburied. I dug up a section and repaired an old improper splice and now the cable needs to be reburied. What is involved is to dig up a short section of cable above the splice where the cable leaves the road.

Finish digging up the cable from the splice to where the cable goes under the pavement. Dig the trench at least 12 inches deep and rebury the cable.
