Top three shooters were: Trade Gun: 1st Allen Cunniff, 2nd, Mike Nesbitt, 3rd Will Ulry, Rifle: 1st Allen Cunniff, 2nd Bob DeLisle, 3rd Mike Nesbit, Pistol: 1st, Bob DeLisle, 2nd Doug Simpson, 3rd Mike Nesbitt. Now at this point you might speculate from the various placings who deserves the overall title but the Luck Shoot results settled at least the "Luck" category. Bob DeLisle won both the Poker Cards (with a Jack high Straight Flush) and the gopher shoot!

Free Trapper meeting following the shoot was brief. Discussion topic was the Scout Spring Hunt scheduled for the match day, next month. Free Trappers, in traditional attire, will host and facilitate traditional events for Centralia area scout troops and conduct a rifle only competition concurrently. Go to www.blackdawgpartners.com/ Utah for information on requirements. Please call Richard Walker at 360-413-0575 or email him at blackdawgswp@hotmail.com to reserve your spot. Let him know you are signing up for the CCRP class.

We will be charging \$130.00 for this class. CCRP members will receive a \$10.00 discount. If you look at the requirements you will see that a large percentage of this fee is processing. The permit is good for 5 years.

Beginner/Intermediate Pistol Match February & March

The February Beginner/Intermediate match drew 21 total shooters and 28 guns. The match was 72 rounds shot at bowling pins and steel. For this match, we also included a separate 18 round run and shoot stage that included paper, bowling pins, and steel. A good time was had by all. There were 12 Beginners, 7 Intermediates, and 2 Advanced shooters. We had a good day for shooting and the match was completed by 1 PM.

The basic six stages were all 12 shots each and included steel targets and bowling pins. Beginners shot from 12 yards without any time limit. Intermediates shot from 20 yards with no time limit. Advanced shot from the 10 yard line – weak hand only, the 20 yard line- strong hand only, and the 30 yard line - optional grip. No time limits were imposed on the advanced shooters.

The run and shoot stage was the highlight of the day. In addition to being a run and shoot, shooters were scored on the amount of time they took to complete all 4 positions. Shooters started sitting in a chair. On the command to fire, shooters loaded and moved to an obstacle where they shot 3 steel targets from the prone position. Shooters then ran to the second position where they shot 3 shots at paper plates at 5 yards, reloaded, holstered, and moved to the 3rd position. At this position, shooters shot 6 rounds at bowling pins, reloaded, and moved to the 4th position. At the 4th position, shooters completed the stage by shooting at 6 steel plates. Petr Bastor was the only shooter to hit all 18 targets although 4 other shooters hit 17 targets. Petr's time was 1.08 minutes. Ron Lohman had the fastest time at 56 seconds but he only hit 16 targets.

If you know any beginners who want to learn safety rules and basic shooting skills, bring them to the Beginner/Intermediate match on March 14th. All other pistol shooters are also invited. We recommend that you bring 100 rounds to the match. As a reminder, we ask that shooters show up at 8 AM to help set up targets for the match. Also, all shooters who have not shot in this match are asked to attend a 30-40 minute briefing before shooting, which covers match and range safety procedures and commands.

The March Beginner/Intermediate match drew 17 shooters amid a driving rain storm. Rain lasted until the very end of the match and every shooter there was drenched to the skin. There were lots of cold feet and hands. Luckily, the wind didn't blow or it would have been really miserable. There were 9 Beginners and 7 Intermediate shooters. The match was completed by 11:30 AM.

The match was 72 rounds shot at bowling pins, paper, and steel. Also included was an 18 round walk and shoot stage that included bowling pins and steel. The walk and shoot stage was completed on the long bay where shooters shot from three different locations over a 50 yard space. The stage also included shooting with a pre-staged 45 Colt Single Action Revolver and a 45 Colt carbine.

The other three stages were all 18 shots each and included steel targets, paper targets, and bowling pins. Beginners shot from 12 yards without any time limit. Intermediates shot from 20 yards with no time limit.

If you know any beginners who want to learn safety rules and basic shooting skills, send them to the Beginner/Intermediate match on April 11th. All other pistol shooters are also invited. We recommend that you bring at least 100 rounds to the match. As a reminder, we ask that shooters show up at 8 AM to help set up targets for the match. Also, all shooters who have never shot in this match are asked to attend a 30-40 minute briefing before shooting, which covers match and range safety procedures and commands.

MEMBERSHIP DUES RATES Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues \$70.00 for the first member of each household and \$35.00 for each

additional eligible member of the household.

Initiation fee (one time) \$80.00 for each household and a refundable gate card deposit

fee of \$10.00 for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually

or recruit two new members or pay an assessment of \$80.00.

Western Washington's first rendezvous allowed buckskinners to hit the rondy trail just south of Littlerock, where the Puget Sound Free Trappers of Capitol City Rifle and Pistol Club hosted their annual event. Starting at noon on Friday February 14th, Booshway Bo Brown opened the gates for a dry, cool session. Fair weather and cool nights greeted the 102 registrants, comprised of 12 under 12's, 8 juniors, 6 women and 72 men. 25 campers had at least bearable weather conditions. They almost got to take dry canvas home until rain started Sunday noon. Over a dozen traders welcomed the patrons including a number of visitors from the community.

The full-size competitors had a range of typical events: Rifle, Trade Gun, Pistol, Knife & 'hawk and Archery trails. Don Kerr headed the shooting trails while Tim Sampson ran the Knife & Hawk event. Capable helpers: Chris Miller, Ralph Buckingham, Allen Cuniff, Josh Brown, John Vladeff and Tony Yaklich along with some others whose names may have escaped kept the trails working. Aggregate scores could combine either archery or Knife &'hawk with the Rifle trail. Will Ulry and the Capitol Bowmen managed the Archery event. Will and Glenn Sutt handled the Under 12 shooting events. Off the trail had the Ray Baker blacksmith exhibition along with the Trader's fair as well as the Club House kitchen to help pass the time. The WSMA held their annual meeting Saturday afternoon. Saturday evening gathered all comers to the Pot Luck which had Buffalo Roasts provided by Will Ulry to complement the results of the Dutch oven competition. Trade Chief Steve Andrews was in charge of the evening's events. Trader's Auction and Poker Tournament filled out the agenda. Lots of folks pitched in to get the details taken care of which included some of the "guests" as well as the hard-working Free Trappers.
