Beginner/Intermediate Pistol September 2009

The Beginner/Intermediate match only drew 9 shooters for the September match. We had a beautiful day for shooting but many of our regulars decided to attend other functions like birthday parties. Three shooters tried their hand with a second gun.

The match was 72 rounds shot at bowling pins, paper, and steel, with the possibility of 6 bonus points. The walk and shoot stage started with the shooter sitting on a bed with gun and ammo on a nearby table. The shooter heard his neighbor making a huge ruckus, got up and walked to the table, picked up the ammo and gun and moved to the first stage where we shot two bad guys through a barrel. Then, the shooter saw his neighbor coming after him and shot him at 40 yards. At the next stage, the shooter shot 2 shots through a second barrel, and moved to a bonus station where, if chosen, the shooter could shoot 6 targets with Ron's single action 45. After the bonus stage, the shooter shot two more targets, one on each side of the course of fire. Finally, shooters reloaded, shot one target on a stand, moved to the final mat, and shot 5 plates off the Texas Star. If the shooter didn't complete the entire course of fire in 95 seconds, any of the bonus shots did not count. Targets were positioned behind clumps of grass and tree branches so that they were hard to see clearly.

The other five stages were all 12 shots each and included steel targets, paper targets, and bowling pins and were fairly standard fare for Ron's matches. The 5th stage was shot from a platform and included a tree and 6 bowling pins set closely together. Shooters had to shoot the pins one at a time, starting from the back of the line of pins. If more than one pin fell on a shot, none of the 6 pins counted. This tended to reduce a lot of scores.

All classes shot from the 12 yard line without any time limit. Beginners were allowed to shoot all five stages with a two-handed grip. Intermediate shooters had to shoot two of the first four stages with their weak hand and had to designate in advance which two they chose. Advanced shooters shot the first four stages with the weak hand. All shooters shot the 5th stage with a two-handed grip. All in all it was a really fun match to shoot.

All pistol shooters are invited to the match and you can really hone your accuracy skills with this match. If you know any beginners who want to learn safety rules and basic shooting skills, send them to the Beginner/Intermediate match on October 10. Shooters should bring a hip holster and a center fire pistol – semi or revolver – of 9MM or larger caliber, and 3 speed loaders or magazines. Cross-draw and shoulder holsters are not allowed. We recommend that you bring at least 100 rounds to the match. Any shooters who do not have the needed equipment may borrow equipment from Larry or Ron. We ask that shooters show up at 8 AM to help set up targets for the match and stay and help tear down the targets after the match has been completed. Matches are usually completed by 1 PM.

MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)
