Indoor 4-P Begins Next Month

It's time to dust off the rifles, see if our shooting jackets still fit and start the stretching exercises. Capitol City's 2010 Indoor 4-Position Rifle league begins the first Wednesday night in December.

League shooting will be conducted at 7 p.m., Dec. 2 – March 30 at the Indoor Range. Like last year, the first few sessions will be devoted to coaching, practice and checking equipment, followed by a 12-week "fire for record" league match.

The 40-shot NRA sanctioned event will be fired in four strings; 10 shots each from the prone, sitting, kneeling and standing positions. League fee is \$20, targets will be provided and scores can be used for NRA skill classifications in the 4-P Rifle discipline.

Shooters can use single-shots or repeaters, loading one round at a time. Rifles may be scoped or iron-sighted. As in past years, some shooters will use heavy, highly-accessorized target gear. Others opt for lighter Plinker style rifles to gain or improve their NRA standing in Sporter Class .22 rifle.

In addition to Smallbore enthusiasts, the league also draws riflemen whose primary interest is in Highpower, Silhouette, Field Target or CMP. Winter shooting sharpens their competitive edge for spring and summer events. Practice and coaching also enables more casual shooters to fire better groups than they ever imagined with their favorite squirrel rifle.

Wednesday nights with a good rifle, fellow club members and a roof overhead is a great way to make shooting a truly year-round sport. For more information, contact Tom Krugman tkrugman@comcast.net or Jeff Young jefyou1@gmail.com.

Board of Director's Meeting October 1, 2010

Minutes as Recorded by Chris Moffet, President, and Darrell Gehlsen, Treasurer.

The meeting was called to order at 7:00 p.m. and the roll was called.

Resigned: Robert Levesque.

Guests: Bob Gietz, Bill Allen, Rob Davis.

Darrell Gehlsen presented the Treasurer's Report, J.K. Johnson made a motion to accept the report as read, John Mulhall seconded, and the vote in favor was unanimous.

John Mulhall reported that the membership was holding steady and there is to be a New Member Orientation on October 13.

Old Business:

1) Range Expansion Report: The Executive Committee met with Tom Krugman on September 27, 2010 to review the changes to the Range Expansion Plan. Being satisfied that the plan made the best use of available resources for the money to be spent, the E-comm voted to approve the initiation of the plan and Tom Krugman will get it started. A huge thanks to Tom for all of his efforts in this. We are learning that when dealing with bureaucracies, nothing is easy or simple even when it should be.

New Business:

- 1) A question arose over using monetarily compensated hours to fill the assessment requirement for membership. Simply put, the answer is no, that is not allowed. If you were paid for something you did at and for the club or an event, you may not claim those hours against your assessment.
- 2) Bill Allen submitted his assessment card for 19.5 hours of heavy equipment work at the club property. By prior agreement with the board, Bill's hours are valued at \$35.00 per hour and applied to his assessment until that value is used up.
- 3) Bob Gietz reported that he had learned that minors – or parents/ guardians for – cannot waive their rights (hold harmless). However, any event, whether involving the shooting sports or not, or involving minors, are to have hold harmless agreements signed by all involved. The event descriptions need to be quite detailed of what is going to happen and the event should not vary. Hold harmless agreements are to be signed by guests of members as well. This provides a record for the club that the individuals involved recognize the inherent risks of participating in potentially hazardous sports and/or activities. A hold harmless agreement signed by an adult, including by a parent or guardian for a minor, shows the person holds no pre-conceived intentions of holding the club liable for injury received at the club. Thank you, Bob, for your report.
- 4) Capitol City Juniors: John Crossman took the WA state team to the Nationals in New Mexico where the team took third and the sole representative from the CCJRs took third as well. Congratulations to all of you.
- 5) No parking zones as designated by the club are exactly that – No Parking. You may load and unload there, but you must then move your vehicle to a designated parking area. Loading and unloading in a no parking zone may not take place during live fire. CCRP is working on a CCRP-issued "Disabled Person" parking permit and parking areas. As that is developed, you will be informed. Please note that CCRP is a private organization and is not subject to the state or federal ADA requirements.
- 6) Board of Director elections are coming up in December and one position is open for certain. So,

with the agreement of the board members present, the Nominating committee was selected and includes all the board members who weren't present for the October meeting. The following board members terms expire at the end of 2010:

Chris Moffet, Rick Baldwin, Ray Crisp, Brian Erickson, Bob Greenman, Irene Hertwig, and Tom Krugman. If you wish to continue serving on the board please notify the Nominating Committee as soon as possible. A suggestion was made to check out last years's new member forms for those who wished to volunteer.

7) With a request from Irene Hertwig, a motion was made by Darrell Gehlsen to allow the AP Range to spend \$1000.00 or less on steel targets, a second by John Mulhall, the vote in favor was unanimous.

Tom Krugman made a motion to adjourn, a second by Doug Simpson, the vote in favor was unanimous. The meeting adjourned at 8:15 p.m.

MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)

Free listing of events on NRA website; discount on range technician team & service; attorney referral service; non-legal advice for legal problems; NRA attorneys pro bono for national concern issues; eligible to apply for \$5,000 grant annually; \$10 reimburse for each new NRA member; \$5 reimburse for each returning member; "Club Connection" quarterly magazine; eligible for NRA firearms insurance.
