# NW Evergreen High School Rifle League Report (2009-2010, 2010-2011)

The NW Evergreen High School Rifle League trophy lists winners back to the early sixty's. There are currently five teams that compete including the two Tumwater School District High schools. (Tumwater and Black Hills) These teams compete in NRA precision small bore competitions like the CCRP Jr team. CCRP has been a strong supporter of these teams from their beginnings. The most visible support is access to the indoor range during the winter for practice and matches. Their season starts in mid-November and finishes with a standing match in early March.

The league has four traveling trophies and awards individual medals with a limit of two medals per shooter. The League match trophy is awarded for the most wins in a season based on a handicap system. This allows competition between teams with different levels of experience with favor given to the team that is improving. The JV teams compete on the same system for a JV plaque. The aggregate trophy is for the highest raw scores during the matches. The standing trophy is given to the team that shoots the highest score in the 40 shot standing match held at the end of the season. Individual medals are presented for the top aggregate score, the top standing, kneeling and prone aggregate scores. A shooter may receive only one of these medals. A separate medal is awarded for the top shooters in the standing match.

In the summer of 2009 the Tumwater school district eliminated the budget for most athletic programs including the rifle team. Concerned parents and shooters surprised the school board and were able to get an agreement that the program could continue as long as it did not impact the district budget. Since the schools had dropped almost all support beyond a small amount paid to the coaches, this was not a significant problem.

Interest was very high at the beginning of the season, 13 students participated through to the end of the season at Black Hills HS. Tumwater started with over 25 and ended up with more than 15 at the end of the year. Black Hills had scores that were undoubtedly unprecedented in its history. During the first match, 9 of the 10 competitors (5 from varsity and 5 from JV squad) scored above a 200 (300 is perfect). The varsity squad all scored above 250. Black Hills and Tumwater HS fin-

ished 1st and 2nd respectively in the league and also placed the same for aggregate scores. W.F West (Chehalis) took the JV plaque.

The two Tumwater School District schools received 15 of the 21 individual medals in the league. Black Hills won the 40-shot standing match at the end of the season with Tumwater finishing second. Both schools participated in the NRA 4-position regional competition and finished 1st and 2nd in the state. In the spring of 2011 when looking at the match bulletin, a familiar name appeared as last year's winner. Black Hills High School took top honors in the scholastic division. Black Hills gym now has a banner for a national level title, the first in the school's history!

The two schools cooperated in fund raising and in grant applications. Together they raised over two thousand dollars this does not account for many hours of volunteer coaching, transportation, and other support. Two grants from the Friends of the NRA and support from Cabela's also helped.

The 2010 season started on a better note - without having to argue with the school district over the survival of the program. Once again the competition between Tumwater and Black Hills was intense. Shelton and Centralia returned most of their shooters and their scores reflected this. Two of the matches shot by Black Hills resulted in ties which were broken by the numbers of X's. Winning by the number of X's in the match against Tumwater gave Black Hills the League Match Trophy for the second year. They also took the aggregate and standing match trophies again. Centralia took the JV plaque. The league had 65 High School students participate in matches with an additional twenty to twenty five students starting out but not getting to competition. This is a valuable experience for these high school students. The lessons in safety and respect will stay with them all their lives. Many of the current members of rifle clubs were introduced to shooting sports by these types of programs. The shooters and their parents are particularly grateful to Capitol City Rifle and Pistol Club for their continued support. Without the support of the club and the help of many of it's members, these programs could not exist.

### **Boy Scouts Early Spring Hunt**

Boy Scouts from Troops 93 (Morton) 300 (Centralia), 310 (Rochester) and 327 (Winlock) all being part of the Timberline District of the Pacific Harbors Council came to Capitol City Rifle and Pistol Cub on April 9th for a combined "Spring Hunt" with the Puget Sound Free Trappers. "Spring Hunt," from the Fur Trade tradition by the Puget Sound Free Trappers, offers Scouts the opportunity to participate in shooting muzzle loading rifles, to try Archery with 3-d Targets, and to walk and "throw" on the Tomahawk Trail. In addition, the participating Free Trappers had an opportunity to demonstrate their skills with muzzle loading rifles on a mix of paper and gong targets for blanket prizes with the order of awards based on the shooters' aggregate scores.

Along with the shooting done by the Free Trappers in their competition, Don Kerr gave the Scouts an excellent demonstration of how a flintlock loads and works. Many of the Scouts had never seen a flintlock rifle, as we can easily expect, and for their own shooting the Scouts were using percussion rifles. Watching a flintlock being fired is always entertaining and the boys were generally very interested.

Range Director Tom Witt was very instrumental in bringing this event to occurrence through interaction with the Centralia Scout round table. Twenty nine scouts and 10 adults came to this big event to walk the trails and test their skills. 17 (15 Scouts and 2 adults) received the WSMA "Pilgrim" medals given to first time shooters. The Washington State Muzzleloaders Association (WSMA) provided a grant which gave us the shooting components and items to the prize blanket along with the top competitor and pilgrim medals. Recognition medals were presented to the top participants. Rifle shooting awards went to Gabriel Tveten-1st, Dean Houinghof-2nd, and Mike Kvavle-3rd.

Tomahawk throw: Tylor Neilson-1st, Conner Simons-2nd, and Mike Kvavle- 3rd. Archery top scorers were: Tyler Smith-1st, Ian Simons-2nd, Jameson Pasco-3rd. Aggregate awards for top combined scores went to: Conner Simons-1st, Gabriel Tveten-2nd, and Dylan Kimball.-3rd. Adult awards, presented to the top individual in each category went to Ron Topel - Rifle, Scott Kimball - Archery, Patrick Berg - Tomahawk, and to Scott Kimball again for Highest Aggregate.

WSMA Pilgrim Medals were presented to adults Scott Kimball & Steve Coyner, and to Scouts: Dylan Kimball. Nick Draper, Reid Worden, Elliott Chastain, Isaac Eagle, Austin Boyet, Ben Waddell, Ian Simons, Rueben Duncan, Austin Heaman, Caleb Bingham, Arin Eagle and Jason Topel.

Participants from CCRP who made this event possible were Barbara Rheault, Sherrie Crisp and Bob Jamison, CCB Archery. The Tomahawk trail was conducted by Tim Sampson and Dave Perry. Under Tom Witt's direction the Rifle range assistants included; John Vladeff, Ralph Birmingham, Will Ulry, Tony Yaklich, Rowland Zoller, Doug Simpson, Tom Brown, BO Brown, Allen Cunniff, Dave Dolliver, Craig Brown, Frank Ponceroff, Travis Herdt and Mike Nesbitt. This shooting event was made possible with the use of personal rifles on loan for the Scouts to use which also involved additional effort to clean up after being fired for ultimate storage. Additional donations to the Scouts' aggregate blanket prizes came from Free Trappers Ralph Birmingham and Frank Ponceroff. Substantial support of the aggregate prizes came from local sports stores, Cabela's and Wholesale Sports provided in the form of even more blanket prizes. Our deepest thanks must go to those who, in addition to helping on the range and donating their personal rifles for the Scouts to shoot, inherited the final cleanup of the range.

The Free Trappers aggregate awards based on 25 and 50 yard "standing bear" targets and 5 figure "gong" targets hanging at 75 yards went to; Don Kerr-1st, Mike Nesbitt-2nd, Ralph Birmingham-3rd, Frank Ponceroff-4th, Travis Herdt-5th, Doug Simpson-6th, Rowland Zoller-7th, Craig Brown-8th, Bob Gietz-9th, and BO Brown-10th.

## MEMBERSHIP DUES RATES Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues \$70.00 for the first member of each household and \$35.00 for each

additional eligible member of the household.

Initiation fee (one time) \$80.00 for each household and a refundable gate card deposit

fee of \$10.00 for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually

or recruit two new members or pay an assessment of \$80.00.

(<u>GUESTS:</u> Members may bring their spouses and children under the age of 18 years old <u>as guests</u> as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)

### M1 Garand Match Beginning in May

How long has it been since your Garand has been brought out to the range for some fun? Well beginning May 8th and each following month on the second Sunday through September you have a chance to bring out the Garand for some play time.

Capitol City will be hosting a non-sanctioned monthly M1 Garand Match on; May 8th, June 12th, July 10th, August 14th and September 11th. Shooters will need to be on the line and prepared to get underway at 9:00am sharp. We expect to be finished by 1:00pm, but most likely much earlier.

The M1 Garand Match is intended to be exclusive to the M1 Garand; however as with the National John C. Garand Matches, other as issued vintage military rifles of the era such as Springfield 03's, Enfield's, Mauser's, Schmidt-Rubin's, etc. shall be allowed to participate. If you intend to use one of these non-Garand rifles, you will need the appropriate stripper-clip for the rifle to shoot the rapid fire stages.

AR type rifles and other non-vintage type rifles will not be permitted; this is a vintage military match only.

The match fee will be \$10.00. No awards are anticipated as this is simply a time to bring your Garand out for some play. The match does not take the place of the Old Soldiers Match, but it does allow for a bit more fun since there will be rapid fire stages.
