## **High Power Range Notice! Thursdays from noon to 8pm**

Thanks everyone for keeping the HP range clean, it's looking good up there. Picking up your targets and brass does a lot for the appearance, makes it more pleasant for everyone, and keeps the maintenance work load down.

There is still upkeep that has to be done on a regular and as needed basis. In order to do this without having to schedule it several weeks in advance, and shutting the range down on a Saturday or Sunday, every Thursday from noon to 8pm will be priority time for maintenance work. During this time frame, if people are working on a project in front of the firing line (repairing targets, mowing etc.), work will take precedence over shooting. There may not be people working every Thursday, but if there are, shooters will have to wait. Shooters can, of course, shorten the down time by helping. Most of the repair work will take one person less than two hours to complete (with help, probably less than one). The eight hour window is to give volunteers a flexible start time.

So, starting in March, if you want to shoot on Thursday afternoons, you may have to be prepared to wait, and, if you don't mind, to help.

# Minutes

Capitol City Rifle & Pistol Club  
Board of Directors and General Membership Meetings  
January 14, 2005  
Meeting began at 7:02 PM.

Flag Salute – Chris Moffet led the flag salute.

Documents Received – Draft firewood cutting policy from Rich Montecucco. Profit and Loss statement, 1/11/05 – 1/14/05 from Tom Holladay. Mail to Northland Insurance Co. "returned to sender" from Jim Dotterer. Redraft of the CCRP "Hold Harmless" form and a directory for 2005 CCRP Directors from Shirley Rheault. Proposal for use of center fire rifles on ranges other than High Power from Rick Baldwin.

Buildings and Grounds – Jim Dotterer reported that Bob Greenman had volunteered to lead B&G. It was moved, seconded and passed that his appointment as Director of Buildings and Grounds be approved.

Attendance – Jim D. called the roll. All directors were present except Jim Zobrist, who is ill, and Bill Wright, attending a parent who is ill.

Treasurer's Report – Tom Holladay reported the following account balances: checking - \$3,517.96; money market - \$537.64; emergency fund - \$1,209.22; capital projects fund - \$3,895.81 and Home Street - \$83,794.28. Tom reported that we added \$1,106 to the Capital Projects Fund and \$475 to the Emergency fund; and that all bills were paid.

Membership Report – Rich Montecucco reported that he and Linda Holladay have been working to resolve the discrepancy between the number of outstanding gate cards and her membership records but, that we have at least 385 club members.

Rescind Quarterly Only BOD Meeting – At a meeting last year, it was agreed that the full Board of Directors need only meet quarterly and that only the Executive Committee would meet in intervening months. Jim D. noted that meeting this way, the Executive Committee lacked knowledge available only when the full BOD met. He suggested that the club revert to full monthly BOD meetings. It was moved, seconded and passed that the club revert to full monthly BOD meetings.

Big Buck and Bull Contest – Will Ulry reported on this year's meeting. As part of his report, he read a humorous description of a '50s era "Dynamite Shoot" prepared and submitted by Jim Zobrist.

Cutting Firewood – Rich M. and Greg Squires presented a proposed firewood cutting policy. It would entail following a procedure including obtaining the club President's approval, for require the cutting crew to consist of a minimum of two people and require submitting a short written report together with money collected to the President. Only dead, diseased or fallen timber would be eligible for harvest. It was moved, seconded and passed that this policy be adopted. Shirley Rheault proposed that this policy be incorporated into the standing rules. This addition to the SR was approved, also.

Standing Rules – John Cadoo gave a progress report on the work of the Standing Rules Committee. The committee including Will Ulry, Shirley and Jerry Rheault and John C. met once in January. They reviewed the previous draft, developed some proposed changes to the rules, solicited a new job description from the Vice President/Scheduler and discussed the need to include club-wide forms in the SR. At present these would include the following: "Event Application", "New Member Application", "Hold Harmless Form" and "Incident Report." The committee also supported inclusion of an "Event Report" form to be prepared by Match Directors. This report would incorporate the functions of the existing accounting report but, also include information so that a club-wide report could be prepared showing how many club and non-club members participated, the gross collections and expenses entailed in conducting the event and the funds remitted to the Treasurer. Steve Andrews suggested that names be collected for events scheduled on a monthly basis, but not for annual events. This suggestion was agreed upon. John C. mentioned Rick Baldwin's proposal that other ranges (other than the High Power range) be made available for high power shooters due to the fact the capacity of the High Power range is frequently exceeded. He noted that other ranges are not currently set-up for high power shooting but, that their configuration might need to be altered so that they can share the load. However, at present, the club lacks current, accurate usage data for all facilities. There was considerable discussion of what range changes would be needed to accommodate shared usage. No conclusion was reached.

Club House Repairs – Jim D. noted that he and Darrell Gehlsen had spent seven hours searching for parts and repairing the heater. He also pointed out that nine leaks in the roof have been identified. Bob Jamison estimated that the overall cost to repair the club house roof would fall between \$5,000 and \$9,000 depending upon how the club disposed of old roofing materials. In further discussion, it was stated that the original roof was comprised of roll roofing and later shingles were applied over the roll roofing. Shirley Rheault suggested that she advertise in the Plinker for club members who are roofers. Her suggestion was agreed upon but, lacking needed funds, no decision was reached about initiating repairs.

Hunter Sight-In – Jim D. pointed out that no one had yet come forward to volunteer to run this program. He suggested that Bob Searle, who used conduct the Hunter Sight-In sessions be contacted soon while he is yet able to contribute his extensive expertise. Bob Gietz suggested that a separate session(s) be established for black powder shooters and Jim D. suggested that the BP session include BP orientation for those new to muzzle loaders.

Book Keeping Service – Jim D. reported that a neighbor of his, skilled in accounting, has offered to relieve Linda Holladay at the end of 2005.

Membership Table at Gun Shows – Shirley Rheault asked for a volunteer(s) to staff a membership table at gun shows. She said that a "free" table could be set up at shows run by the Washington Arms Collectors (WAC). Bob Gietz pointed out that "free" tables were NOT available at the Centralia Gun Show. A one-day table costs \$35 and a two-day table, \$45. Rich M. volunteered as chair for the membership tables at WAC show and Greg Squires volunteered to assist Rich.

Reader Board – There was discussion about construction and placement of a reader board for advertising club events. Chris Moffet said that the club could construct a reader board if it bought the materials but, no conclusion was reached.

Road Repair – Bob G. reported that he had contacted Martin Sand and Gravel and that the firm had submitted an estimate of

the costs necessary to repair the club's entrance road. He described the work that would be accomplished along 300 feet of that road and indicated that the cost would be approximately \$8,000 without paving and about \$12,000 with paving. Considerable discussion followed about the advisability of paving the entrance road but, it should be done in dry weather. Tom H. pointed out that like the club house roof, no money was available to undertake the road repairs.

Grounds Maintenance – Bob G. also reported on a firm called "Have Hoe, Will Travel" that has offered to perform mowing, grading and other maintenance functions for \$40 per hour. The firm owner is a shooter and might be willing to trade his time for all membership and assessment costs. Considerable discussion followed but, no decision was reached.

Equipment Equivalence Schedule – Greg S. presented a schedule relating assessment hours earned and various pieces of equipment which might be employed. This schedule will be published.

Archery Work Parties – Ray Crisp announced that archery work parties will be on club premises for the next two weekends, i.e. January 15-16 and 22-23.

Adjournment – The meeting adjourned at approximately 9:00 PM.

## Big Buck and Bull Contest

Our attendance was a little down but not the stories or the antler count. The food was good and plenty of it. We feasted on Buffalo burgers, salmon and 2 pots of the greatest beans. There were other tidbits of tantalization also.

In no particular order Remi Hansen started out his first day of retirement bringing his 2003 and 2004 Montana Mule Deer for our big boy show and tell. Ray upgraded from his 2003, 113 5/8" to his 2004, 131 7/8", 3x4. Ray popped this guy in the last 20 minutes of the hunt. A much bigger buck had just eluded him at something over 300 yards giving him nothing but a Texas Heart shot. Mr. 3x4 presented himself at 200 broadside and meat in the locker was the name of that game.

Will and Ray brought this guy and 5 does to the freezer this year from Montana.

Tony Pannkuk had one great hunting season. Tony has also retired and started writing hunting stories, hunting more and has become associated with Larry Wisebaum. You may recognize that name from his numerous hunting shows he has been doing. Tony got a couple great bears in Canada. He was fortunate to get a black grizz. Approaching this bruin with 2 killing shots already administered to his heart the grizz still had enough left to take a swipe at the guide. I'll bet that guide remembers that hunt for a while. Tony also brought a big wide Wyoming 3x3 to the festivities. Tony remembers that hunt because of the tremendous amount of hunters in the area. It scored 120 5/8".

Club member Dean Bender proved New Mexico has nice bucks. Dean said it took his brother and him 2 days to drive to the public hunting ground. Dean said it took sometime to get this guy back to camp only to be greeted by his lounging brother already there with a monster 184 point buck. His 135 2/8" buck was no slouch although. You know about competition among siblings. It was a good one.

Larry Balestra just wasn't going to be missing out on getting his name on the stump this year. He brought photos of a Montana Whitetail that would knock yer socks off. He made a long stock and a good shot on a 5x6 that scored 176 4/8". This guy is well into the Boone and Crocket book. Our rules are simple and the antlers are to be brought to the festivities. To cinch his spot on the stump he brought the only elk shot by club members this year. It was a 4x4 shot at Winston Creek. He has become friends with some archery hunters that lead Larry to this one on opening day of rifle season. They have been doing well by Larry the last 2 years. Despite a 111 1/8" score he was good eating.

Pete Strobel got the Big Buck award. He also got a Montana Mule Deer. Pete said it was the biggest buck he ever shot. Pete had salt on his bullets and wings on his feet to catch up with him. He said he was so far away when he shot he bought a bus ticket for the bullet. This nearly perfect 5x5 scored 164 7/8" and makes the book.

The last 2 winning entries are special because they Washington grown and harvested. Bob Backman who cooks a mean pot of beans got a wall hanger Muley in Kittitas county. He spent an extra hour out witting some does only to show up in the nick of time for this 127 7/8" bruiser to show up and die to another long shot. This one lost a lot of deduction points due to the forks being opposite side to side. This was the widest buck entered at over 27". He was so heavy they delivered the picture by UPS and a fork lift. Bob had to cut it in half to move it a 100 feet to hang it in a tree. Bob wins the Big Washington Buck.

Saving the best for last Bob Lund submitted a life time entry. After 20 years of putting in for a Washington Moose tag Bob finally scored. When he received the tag in June Bob changed his whole summer schedule for scouting the Huckleberry hunting region near Spokane. With some hard scouting, some diligent research, hours talking to wildlife biologist and support from a couple of good friends Bob succeeded. The great part of this story was he got to shooting range of this 8x8 bull on his quad. Added to that they were able to get the pick up close too. Bob says it take 2 elk quarter bags for one moose quarter. It scored 122 Boone and Crocket points. Low book is 140. Moose just don't score high by the way they are measured. This guy was 45" wide. Bob says his best estimation is that it's like shooting a black angus on stilts. Bob is also a hell of a pot of bean cooker. Are you hiring out for camp cook Bob?

It was another good year for friends, stories, food and big racks.
