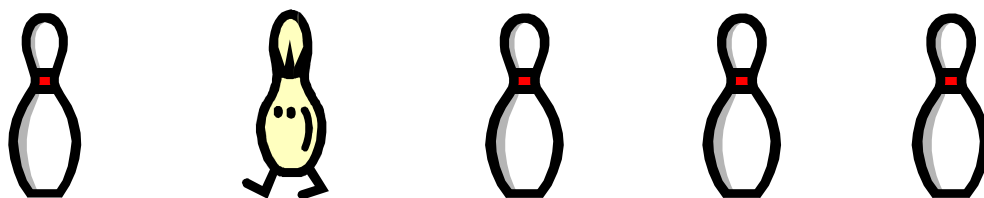
As an old base ball player said, "it ain't over till its over" and it ain't over yet!

The championship was held in Bloomington, Illinois, at the Interstate Center between July 6 and 10. The team representing Washington included CCJRC member Odie Gunter, from Lewis County, Katelyn Woltersdorf from Vancouver, Harley Jette and Darcie Estep from Paul Bunyan, and Justin Malone from Wenatchee. The team placed fourth in the nation with Odie being the top shooter on the team. What a great accomplishment! Congratulations.

**MEMBERSHIP DUES RATES**

*Dues and Renewal policies are effective September 1, 2003*

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class.

# Minutes

Attendance - Chris Moffet called the roll. All directors were present except the following: Ray Crisp, Jim Dotterer, Mike Iyall, Bob Gietz, Bob Greenman, Ron Morton, Jerry Rheault, Greg Squires and Jeff Young.

Treasurer's Report - Request to waive assessment: John Cadoo reported that Stephen Prohaska had requested that CCRP waive his assessment. He offered no justification for the requested waiver. A letter was mailed to him indicating that the Board would need justification for such a waiver. He subsequently spoke to Jim Dotterer and agreed to turn in his gate card during July. Receipts: John Cadoo reported that he has started giving receipts for money received from Match Directors and that members wishing to be reimbursed will need to provide him with receipts covering their expenditures. Check writing: Jim Dotterer and John Cadoo have agreed that all checks written for the club will have two signatures, the President's and the Treasurer's. As a general rule the Treasurer will not be writing checks at monthly meetings. If you provide a receipt for reimbursement, you will be reimbursed by mail. New Account: The club has opened a new account at Heritage Bank. For the time being, all incoming checks and cash will be deposited into this account and all club checks will be written against this account. Balances: As of July 7th, the new Heritage Bank account check book balance was \$3,433.85 (the bank reported a higher balance) and the balance of the Homestreet account was \$84,488.64. No balance information was calculated for the other Heritage accounts. Puget Sound Energy Billing: The club learned that PSE has been separately billing the club for the electronic gate. A request was made to combine the gate and clubhouse billings in the future. Money Deposited/Checks Written: John provided a listing of checks written and money deposited for anyone who was interested.

Secretary's Report - Timber Sale: The Department of Natural Resources wrote CCRP that it has completed a timber sale along the South boundary (behind the Action Pistol Range) of the club. Harvest will begin in 2006. Fire Insurance: Sunset Insurance Agency wrote the club to say that the club house and other structures are grossly under insured. Currently CCRP is insured at the rate of \$12/sq. ft. Replacement cost would be at least \$50/sq. ft. John requested a motion from the Board to request Sunset to propose alternatives for more realistic coverage. The motion was made, seconded and passed.

Investigation - Chris Moffet reported that the club's financial situation is currently the subject of a criminal investigation. Chris warned that BOD members shouldn't talk about this investigation because it might compromise the investigation and/or subject the club to a liability suit.

Membership - Rich Montecucco reported total membership remains about 390 members, 28 of whom are life members.

Clubhouse Roof - Shirley Rheault asked about the status of the roofers' proposals. Chris described three proposals received from Pro Comp. Briefly stated number one proposed that the contractor do all the work required including providing the materials for \$65,000. Number two proposed that CCRP provide the materials and the contractor do all the work for \$49,750. Number three proposed that CCRP provide the materials and remove all the debris (contractor furnish only roofing labor) for \$25,000. Under each of these proposals, the contractor would require 80 per cent down and 20 percent of the cost on completion. After considerable discussion and questions Darrell Gehlsen moved that this item be tabled until the BOD's questions could be answered. The motion was seconded and passed.

Work Parties - Will Ulry indicated that a temporary sign was in place by the highway and requested help in restoring the old sign. Apparently letters were purchased but, someone (?) picked them up and their whereabouts are not known. Shirley R. said another work party is scheduled. Jim Zobrist said that he agreed with Jim Dotterer that work be scheduled on one range or project at a time so as not to require closing down all facilities at once. Will U. commended the family (Mother and four kids) who came to support workers on the June 11/12 work party. Shirley said that she will contact range directors to ensure that they have the tools and materials that they need for work on their ranges.

Gun Show Hosts - Rich Montecucco requested volunteers for the August 13th gun show. Chris M. volunteered.

August Pin Shoot - It was moved, seconded and passed that Rick Baldwin run the August pin shoot.

Road Work - The Everson Asphalt bid to regrade and pave the entry road is \$8,238.52. This bid assumes that no problems are encountered in the work. If problems are encountered during the work, there will be added charges not to exceed a total cost of \$14,000. Assuming the contractor agrees, the BOD approved a down payment on the work of \$4,000. Will U. proposed that he and/or Bob Gietz oversee the work and either one OK any costs that exceed the basic bid. The BOD approved giving this authority to Will and/or Bob. Issues still remained as to 1) the proposed thickness of asphalt to be laid: two inch or three inch 2) whether the contractor will accept CCRP's down payment and 3) whether or not members will have weekend access to the ranges. Chris M. will contact Everson to resolve these issues.

Women On Target - Shirley R. reminded the BOD that W.O.T. is scheduled for July 16-17.

Remove/Repair - Noel Vaughn, speaking for Bob Greenman, reminded the BOD of the need to remove extraneous materials, such as lawn darts, now stored in the club house. He also mentioned that the club's brush hog needs to be repaired.

The inception of this discipline embodies the American Principle of the right of free men to keep and bear arms which distinguished American principles from the beginning and is perpetuated in the Second Amendment to the Constitutions. The Guild's meeting will feature classes in gun making skills available by pre-enrollment along with featured programs on significant American arms. Particularly on Friday night and Saturday morning, sessions are being held by a master craftsman, Jack Brooks.
