<u>MEMBERSHIP DUES RATES</u> Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues \$70.00 for the first member of each household and \$35.00 for each

additional eligible member of the household.

Initiation fee (one time) \$80.00 for each household and a refundable gate card deposit

fee of \$10.00 for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually

or recruit two new members or pay an assessment of \$80.00.

<u>Treasurer's Report:</u> Darrell Gehlsen reported the following balances; Homestreet \$29,979.13, Certificates of Deposit \$82,150.58 and checking \$6,392.39. Darrell also reported that the club year to date net income is \$21,760.85. We are still looking for an accountant experienced in working with non-profit organizations. Bob Gietz made a motion to accept the Treasurers report, Larry Lufkin seconded. Motion carried.

Membership Report: No Report. Bob noted that he expected 8 or 9 to be at the orientation on Saturday.

Old Business

<u>Retiring Directors:</u> A few of the current members of the Board will be completing their terms at the end of the year. Chris noted that we are still looking for candidates. It is a great way to give back to the club and it does count towards your yearly assessment. Larry L. noted that it might be better to operate with fewer board members than we presently have. <u>Timber Management:</u> Chris reported that we are waiting for the outcome of I-933 before moving forward. Range directors need to have long range dreams laid out so the club can fold them in to the management plan. Darryl also note that range upgrade ideas should include a "Return on Investment" summary with all plans.

<u>2007 Budget:</u> All range directors need to develop their budgets for the upcoming year. If a budget is not developed, the Board will find other places to spend the money. Once again, in the words of Larry the Cable Guy, GIT-R-DONE.

New Business

Black powder Match Schedule: Black powder matches will begin on the first Saturday in December.

<u>Membership Applications</u>: Bob G. presented the new form. Larry noted that there should be something that explains the ongoing assessment fee. Motion was made by Larry L. to add new language to the Pledge and Release section. Noel V. seconded, motion carried.

<u>Big Buck & Bull:</u> Will noted that only four mighty hunters showed up last year. This year's event will be co-sponsored by Tumwater Sports and CCRP and is open to all comers. The event will be held at CCRP on January 10, 2007. Bring your horns and your appetite to this fun event.

Pheasant Hunting

Have you heard about South Dakota pheasant hunting? Well I got to experience it first hand this year. It is as great as I could have imagined. Two friends of mine from the Seven Rivers Mountainman Club packed up our gear and went to Mitcell, South Dakota. Yes, we did take era correct guns but we nary dropped a flint. Hunting was too fast and furious. Pheasant hunting doesn't start till noon so this was a little laid back but it left plenty of time for Cabela's. Katie bar the door. Believe me Cabela's was plenty glad to see us. We went thru AAA Pheasant Hunting owner and premium guide Koby Mahrt. Koby has several guides but hits the fields daily. He has 37,000 acres leased. We gathered daily and caravanned from 20 to 70 miles to hunt. The first day 9 of us hunted and got our limits in 2 hours. Koby did everything by the book so limits were counted often. The second day 11 scored our limits in 4 hours. Every day the birds seem to get smarter. The third day 5 of us got'm in 5 hours. Lasal Johnson was our guide that day. Lasal is a National Field Trial for hunting dog member. His good dog recently died of cancer so he hunted this year for Koby. His best dog now is Doc Holliday. We knew it too when Doc made a 400 yard retrieve. It was one of the highlights of the whole hunt. The last day 16 made the hunt. We covered some mighty big fields. It is incredible seeing the birds that escaped let alone the ones we got. Mark, Kelly and I had a ball. If you are interested in a hunt, Koby is on the computer under AAA Pheasant hunting.
