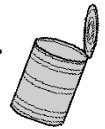

Luck shoot prizes went to Doug Simson for the Dart Board Target and DeWayne Pritchett for the Mike Fink cup. Individual winners were: Trade Gun: 1st-Mike Nesbitt, 2nd- Don Kerr; 3rd- Will Ulry. Rifle: Mike Nesbitt-1st, Bob DeLisle-2nd, and Don Kerr-3rd. (The rifle gongs were out to 100 yards and shooting the lighter (40) calibers took a sharp eye to verify a hit.) Pistol: Tim Sampson-1st, Will Ulry-2nd, & Bob DeLisle-3rd. Aggregate prizes from the trapper donated blanket were: 1st-Mike Nesbitt, 2nd-Bob DeLisle, 3rd-Don Kerr, 4th-Will Ulry, 5th-Glen Sutt, 6th-DeWayne Pritchett, 7th-BO Brown, 8th-Doug Simpson, 9th-Dave Perry.

At the Free Trappers meeting the needed work days were discussed and solicitation prepared for participation. There will be a "Yard Sale Table" opportunity at the Rain-dee-voo for participants to dispose of extraneous equipment and supplies. Regarding the Tenino Oregon Trail event, possibilities were discussed for a Trapper's Run and more primitive camp in the open area if possible.

Be reminded that the Evergreen Muzzleloaders will have their monthly shoot on January 10th featuring a variety of Trade Gun adventures.

## Beginner/Intermediate Pistol January 2010

The Beginner/Intermediate match drew 12 shooters for the January match of which six were first-time shooters at the match. It was supposed to rain all day but it turned out to be clear and we had a beautiful day for the match. A couple of propane heaters helped keep the crew warm during the early part of the match. Four participants chose to shoot a second gun. The match was 72 rounds shot at bowling pins, paper, and steel. In addition to the walk and shoot, Ron included a second "shoot while walking" section.

The walk and shoot stage started with the shooter sitting in a chair with ammo on a table. The shooter stood up, walked to the ammo table, picked up ammo, and loaded while walking to the first stage. The first stage included two shots at paper targets followed by two shots through barrels, and one shot at a plate. The second stage included five shots around barrels. The last stage included two shots at long distance at steel plates. Shooters were given 90 seconds to complete the entire stage.

The "shoot while walking", stage 1 included two shots at two paper targets and two shots at steel targets. For stage two, shooters reloaded behind a barrel and shot two shots at two more paper targets and two more shots at two steel targets. Shooters had to keep moving or the hits did not count.

The other three stages were all 12 shots each and included steel targets, paper targets, and bowling pins. Stage 1 included a plate rack and assorted other steel plates and bowling pins, shot in any order. Stage 2 included three paper targets varying in size from 4 inches at 10 yards to 6 inches at 15 yards and 8 inches at 20 yards. Stage 3 included the Texas tree along with assorted bowling pins and plates. Shooters had to shoot six bowling pins that were set behind steel plates and only the top 3 inches of the pins were showing. Shooters lost two points if they hit the plates in front of the pins. Beginners shot from the 12-yard line while intermediate and advanced shooters shot from the 20-yard line. All shooters were allowed to use a two handed grip and there were no time limits.

Dan James was best of the beginner class with a 58 followed by David Norcross with a 50. Two other beginners, Gayle Hageman and Mike Heikes, tied for third with a score of 48. In the intermediate class, Gerold Trusty was first with a 56, Tom Eardley was second with a 51, and Barb Rheault was third with a 50. Gary Thorson was first in the advanced class with a 63. The "shoot while walking" and stage three of the standing part of the match were by far the two most difficult parts of the match. No shooters got all of the targets on those two stages.

All pistol shooters are invited to the Beginner/Intermediate match and you can really hone your accuracy skills with this match. The next match will be held Saturday, February 13. If you know any beginners who want to learn safety rules and basic shooting skills, send them to our match.

Shooters should bring a hip holster and a center fire pistol – semi or revolver – of 9MM or larger caliber, and 3 speed loaders or magazines. Cross-draw and shoulder holsters are not allowed. We recommend that you bring at least 100 rounds to the match. **Any shooters who do not have the needed equipment may borrow equipment from Larry or Ron.** We ask that shooters show up at 8 AM to help set up targets for the match and stay and help tear down the targets after the match has been completed. Matches are usually completed by 1 PM.

Jeff Young provided more detailed information to the board about a club member's request to sell his firearms to club members. It was agreed by the board that the firearms could be sold at specific times at the club. The club members could not sell the firearms but members of the club, acting under a private agreement with the firearms owner, could sell the firearms for him as a private transaction. If you've been to the club in the last week, you may have noticed the paint marks on the ground at the club entrance. The board has agreed to move the gate and at the same time repair and upgrade the gate controls. A motion to proceed with the electrical and control services to the new location, not to exceed \$3000.00, was made by Darrell Gehlsen, a 2<sup>nd</sup> by J.K. Johnson, motion passed.

The board is still gathering info concerning the club logo with Jeff Young leading the charge. We are learning what we can and cannot do.

Will Ulry, Jim Robertson, and Darrell Gehlsen provided an update on the Range Expansion project. In short, we need to pay to do paperwork so we can pay to do more paperwork. A motion was made by Irene Hertwig to spend \$250.00 on a drainage scoping permit, a 2<sup>nd</sup> by Darrell Gehlsen, motion passed.

Will Ulry provided a report on the "Shoot Your Eye Out" match. It sounds like a fun time was had by all and a lot was learned for the next go-around. A motion to forgive a \$57.70 shortfall was made by Darrell Gehlsen, a 2<sup>nd</sup> by Noel Vaughn, motion passed.

We would like to keep our gates open to the membership and the actions of a few stupid and inconsiderate people jeopardize that. Anyone caught in violation can explain to the board why they shouldn't be removed from the membership.

A motion was made to provide a 1 year CCRP membership including initiation and gate card fee to the RMEF for their auction by Ray Crisp, a 2<sup>nd</sup> by Ron Lohman, motion passed.

At 8:45pm, Darrell Gehlsen made a motion to adjourn, a 2<sup>nd</sup> by Ron Lohman, motion passed.

### **MEMBERSHIP DUES RATES**

***Dues and Renewal policies are effective September 1, 2003***

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

**(GUESTS:** Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)
