Setup proceeded briskly thanks to Doug, Bo & Don who established the facilities on same day as the shoot to eliminate extra trips to the range. Ten shooters attended including two new arrivals named David Geeraerts and Bob Alexander. Those first-timers had only rifles in hand this time but they'll hopefully return fully equipped. "Hunting and Harvest" was the theme for the shoot and prizes. The prize winners were awarded with choice pumpkins donated by the Victor Rodriguez family farm near Adna. Luck shoot winners were; BO Brown for the buck deer-Tie-breaker where his "10" let him edge out Bob DeLisle, the gopher head was dominated by Don Kerr with a dead-center hit. Each of the lucky winners took home a good sized pumpkin in addition to the cash from splitting the pot. Following the shoot, a Free Trappers planning meeting was held in the club house during a hot-dog and chili lunch provided by the Free Trappers. Booshway Tim Sampson worked through the needs for key positions for Rain-Dee-Voo with lots of openings left to be filled. Mike Nesbitt is Trail Boss again and he will be bringing his roster so volunteers can sign-up for the times they prefer at the next shoot. Consensus was reached on carrying on the Scout Spring Hunt in April and key staff were similarly recruited.

We had a rather small turn out of just 5 individuals for the CMP Match on Sunday, however a total of 8 shooters were on the line for the start of our .22 Caliber Silhouette Match. The foggy morning weather had some of us all over the target in the slow prone stage, but within an hour or so the fog burned off for some great shooting weather.

Ken Horton got the 2 points he needed to qualify for CCRPC Distinguished Marksman. Dennis Coyle earned a total of 5 Distinguished points bringing his current point total to 11. Just 9 more points to go Dennis, you've got three more matches to get it done... Bill England is just 1 point behind Dennis and Tom Krugman needs only 4 more points to qualify for Distinguished. Hope each of you can make the remaining 3 High Power Matches this season to earn your Distinguished Certification.

The .22 Silhouette Match was a lot of fun. We had three new shooters—two brand new Club members—participate. Rod McDonald continues to dominate with an impressive time of 1:08:07 for the Match win. We're wondering if Rod will break the 1 minute time-frame soon. First-timers Paul Paluskas and William Murray came in 2nd and 3rd respectively. Nice shooting guys...

Our next High Power Match is October 28th. It'll be the "Old Soldiers Match". We encourage everyone to come and have some fun. Following the Old Soldiers Match we'll have a Carbine Match. Gary Thorson will be running the event and he always has something interesting planned for the carbine competition.

Incidentally, if you're new to the Club and haven't participated in the High Power Matches, the Old Soldiers Match provides an excellent opportunity get started in high power shooting events. The Old Soldier Match is shot only in the prone (laying down) position, with single load, slow fire. It's a 30 round match shot in two 15 round stages. You have 15 minutes for each stage to get your 15 rounds off. You don't have to worry about time. Before the match gets underway for score, we provide 15 minutes—or whatever it takes—to get your firearm sighted in. The emphasis of this match is more about spending time with folks who like and appreciate old military firearms than the actual competition itself. The Club has several loaner rifles available at no extra cost, so come on out and give it a try. We'll see you at the next Match...

CENTERFIRES OF THE OLD WEST

Following the combined requests to continue the "buffalo rifle" matches, another shoot for the old centerfires was held at the Capitol City blackpowder range. That's when on the second Saturday in September eight of the most rugged (ragged?) rangers gathered under the supervision of Bob Gietz for a blackpowder cartridge rifle match. And this time Bob Gietz joined in the shooting with his Model '92 Winchester slinging .44-40 bullets downrange. The other shooters all used single shot rifles which included one trapdoor carbine and seven of the 1874 Sharps style rifles.

The reason we had more guns than shooters is rather simple; a couple of fellows who don't yet have their own rifles wanted to join us. Those extra rifles were on hand to make sure all bases were covered for their first black powder match experience. New to this game were Ron "Bigfoot" Foly and "Big John" Weger but for their initiation they really dove in head first. On their 50 yard targets both Ron and John got five shots each with a .50-90 Sharps along with another five shots with a .45-75-420. After they got a kick out of that, we move to 100 yards where they fired another five shots with the .45-75 loads but then finished with the big heavy .45-110 shooting 500 grain paper patched bullets. Now they're hooked on Sharps shootin'! Lynn Willecke came down from Bellevue to join us and he brought both his .40-70 and .50-70 Sharps rifles along. Those gave us a wider range of calibers and cartridges.

Like before, each shooter fired at a target posted at 50 yards and then another at 100 yards, firing ten shots at each target. Once again, some shooters started at 100 yards while most of them shot their 50 yard targets first. All shooting was done from any unsupported position, which means anything except from a benchrest. Cross-sticks are used by most of the shooters. Our new Sharps shooters, "Big John" and Ron both did their shooting from the offhand position, perhaps because of unfamiliarity with the borrowed rifles.

Mike Nesbitt just barely took the lead by an X ahead of Lynn Willecke on the 50 yard targets. Mike was using .45-55 "carbine loads" in his light .45-70 Sharps from C. Sharps Arms. Then at 100 yards Mike almost duplicated his 50 yard score, getting a 91 at both distances. That made Mike the winner by just a small six point margin.

Both of our newcomers did rather well, especially when we consider they were using unfamiliar rifles and shooting offhand too. We can expect Ron Foly to be getting a rifle of his own pretty soon. Right now he's still picking out details on what caliber and features to get. There is just as much to consider when thinking about getting a custom breechloader as there is when ordering a good custom muzzleloader.

In addition to the shooters mentioned in the scoring line up, we also had the assistance of Tony Yaklich for scoring and range management. Wayne Miller was a welcome guest who brought his beautiful Remington rolling block in .50-70 along for show. And Bill Wirtaner was there to lent assistance and loading recommendations.

There is really too much to say about how much fun these small shoots with the blackpowder cartridges really are, especially in the small space we have to tell about it here. When those big guns boom they seem to fill the range with blackpowder smoke, sometimes obscuring the targets for shooters who are waiting to fire. Future blackpowder cartridge shoots are not scheduled at this time but there are certainly enough inter-

ested shooters to have more. If you're interested in joining us just speak up. We'll make sure there will be shooting to do.

MEMBERSHIP DUES RATES

Dues and Renewal policies are effective September 1, 2003

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)
