## June 2018 Old West Centerfires Match Report

Fair weather shooters welcome one and all

Eleven shooters were present for this forth Old West Centerfires match for the 2018 series. Our weather was calm, sunny and mild, "Which is so rare as a day In June...." It was good to have Don Kerr back with us and in improving attitude and marksmanship. Ken Kurfurst joined us again and we had a new shooter, he's the manager of the Paul Bunyan 600 yard "Fun Matches," Johnny Schauf. Johnny brought his CPA "Silhouette Rifle," a copy of the old Stevens 44 ½, demonstrating high art in the selection and fitting of wood to metal and excellent example of color-case-hardening of the action. He might have changeable barrels for that rifle but was shooting .45/90s to compete with today..

Jeff Ritter returned with his pristine Winchester 1894 which was re-barreled to 38/55 by a John Taylor to use in the offhand match, truly an excellent piece of work and Jeff even shot pretty well with it. And Bob DeLisle returned his Winchester '92 short rifle in .32/20 to use in the offhand match. That offhand match is shot after the two aggregate targets are shot and it is simply an added target giving shooters a little offhand practice and a lot more fun.

Match prizes were awarded for the aggregate scores with selection for a combination of club-provided meat prizes, plus merchandise items from C. Sharps Arms and SPG Sales. The following results differ from those announced at the range due to a discovered slight error in the scorekeeper's arithmetic. First place went to Allen Cuniff, with a score of 186-2X shot with his C. Sharps Arms Model 1874 in .45/70. Second was taken by Mike Nesbitt with his C. Sharps Arms Hartford Model '74 "Buffalo Gun" in .44/90, scoring 184-3X. Sam Snelson shooting another C. Sharps Arms rifle on .45/100 tied with Mike but took third by virtue of Mikes 3X's at 200 yards versus Sam's 2X's at that distance. Fourth and only one point behind was Don Kerr with 183-X shooting another C. Sharps Arms '74 rifle. Don's is a very nice Hartford Target Model chambered for the .45/90. In fifth place we find Ken Kurfurst, shooting his original Remington Hepburn in .45/90 and getting a score of 181-X. Sixth was Jeff Ritter with his Remington Rolling Block .45/90 earning a score of 180-X. In seventh place was Bob DeLisle shooting his Pedersoli .45/70 with paper patched bullets and scoring 180. Eighth in score ranking was Will Ulry using his Shiloh Sharps .45/70 for 171-3X. In ninth place was Jerry Mayo with his C. Sharps Arms '74 Hartford in .45/70 for a score of 164-2X. Tenth place to Johnny Schauf with his CPR in .45/90 getting a score of 143. We'll see Johnny coming back and getting higher scores, he hadn't shot for quite a while. And our last place went to Phil Wiebe who was shooting his C. Sharps Arms Model 1875 rifle in .45/70 and getting 118-X.

In that rundown of the match and the scores, we can see how "tight" it was because the top seven shooters all scored within just six points. That speaks of some very good competition and while our

short-range matches might not draw as much attention as the longer-range shoots, there really isn't anything "easy" about the short-range black powder cartridge shooting.

After completion of the established course of fire, an optional relay was held for an "after aggregate" match. This was the offhand match that was previously mentioned. The target used was a 50-yard standing buffalo and the 10 participants each fired 5 shots after contributing a quarter to the "pot." Mike Nesbitt pocketed the pot well pleased with his score of 42, using his .44/77 Sharps with paper patched "hunting loads."

The next Old West Centerfires match, hopefully to be shot at 100 & 200 yards again, will be held on August 4<sup>th</sup>, 2018, on the High-Power Range or possibly on the Black Powder range (for 50 and 100 yards) if new construction is underway on the High-Power range at the Capitol City Rifle & Pistol Club just out of Litterock, Washington.

**Old Business****High Power Shooting Shed Project – Will Ulry, Project Manager**

- “Good to go for permit”
- Due to permit delay, inflation and tariffs, the cost of the project will increase by ~\$3,000
- Logging moratorium won't affect us due to rule changes, and tax parcel property subdivisions
- Booming economy is spreading construction teams thin. Project will take a little longer, than previously projected. Now 4-5 weeks vs. 3-4 weeks.
- There will likely be a total closure of the HP range for some portions of the project. Possibility for after-work-hours for range to be open. TBD

#### **New Business**

##### **Safes needed for High School Team(s) equipment**

- Decided raffling a donated rifle was way too complicated due to state rules, fees, paperwork, etc.
- Source found to sell club 2 safes at 50% of dealer's cost.
- Motion to provide \$3500 for the purchase of safes – Larry Lufkin
- Seconded – Ray Crisp

#### **Unauthorized access and use of the Action Pistol Range**

- A member allowed a for-profit business access to the Action Pistol Range on two occasions for multi-day CPL certification shoots
- The business, Old School Gun School, did not contact anyone with authority to allow use of the property, fill out any applications forms, provide certifications, waivers, proof of insurance, or make an agreement to compensate the club for use of the property.
- CCRP AP set up crew “found” a class underway when they arrived to set up a shoot. Crew observed unsafe firearms handling by the class participants.
- JB Herren, owner of the school, attended to Board meeting to see if things could be made right, and have the ability for continued use of the club.
- Many Board members asked questions of Mr. Herren, and found his answers to be unacceptable, lacked business sense, appeared to be oblivious about the risk he put the club in by his actions, and apparent desire to lower his business costs by using our facility for free.
- Board unanimously agreed that Mr. Herren was to leave and never return to the property again under any circumstances.

### **Long time member Thom Jenrette, membership terminated**

- Thom Jenrette, CCRP member since 1989, and certified for access to the AP range, allowed his personal friend JB Herren of the Old School Gun School access to the club on multiple occasions as stated above.
- Thom violated many Bylaws and Standing Rules in a manner that put the entire club at risk.
- The Board decided that Thom's violations were so severe, his membership was immediately terminated, he would turn in all access cards and keys, and leave the property.
- Thom was also informed he could not attend "open gate" public events, or in fact ever be on CCRP property again. Doing so would be treated as trespass.
- The Board does not take this action lightly. These unauthorized activities put the entire club at risk, an irreplaceable 41 year old facility used by nearly 700 members, and multiple high school and adult shooting teams.

### **Donated Table Saw – Eric Boos**

- Jim Crossman donated a table saw to the club, for use in the tractor shed. John's one request is that he have access to it to cut plywood target backboards for range time.
- Board agrees.

### **Card Access Security Panel Electrical Issue – Richard Schneider**

- Card access system was down for 1 or more days. The main clubhouse electrical panel and breakers had been upgraded, and the new breakers are much more (properly) sensitive to overload and tripping. Breaker 21 tripped, and the card system stopped working when the UPS was depleted.
- Ray Crisp will check load balancing on all circuits, and will run a new, dedicated circuit to the clubhouse office for the security system and computer.

**MEMBERSHIP DUES RATES****Dues and Renewal policies**

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees (taxes are additional)**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

**NRA membership (required)****Orientation class (required)**

**(GUESTS:** Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)
