Appreciation extended to those who showed up Friday for range set up; Bob DeLisle and Frank Ponceroff. A good morning with dry conditions made for a well-run match on Saturday. Tom Brown receives a 'thank you' for his assistance in scoring the targets and range management. The only Free Trappers business involved continued recruitment for trail guides. Also, Adam Sampson advised us that no Oregon Trail meetings have occurred yet so there's no details agreed on or confirmed.

Our course of fire for this day was for rifles and trade guns on the range with no pistol activity. Targets were a combination of paper targets together with reactive gongs. We used rather large targets, sized to be a gift to good scoring as an early Christmas present.

## **Old Soldier Match November 2018**

Our "Old Soldier Match" is where we shoot standard issue military rifles, from any country, World War II vintage or older. We had 9 shooters on the line for a foggy morning of fun. In commemoration of the 100th anniversary of Armistice Day (the ending of World War I), those of us who had the U.S. Model of 1917 rifle, shot them in the match. We had 3 Model 1917's on the line, and the match winner used a Model 1917. And all of the Old Soldiers today were either American or British rifles. I guess it helps when you win the war.

The Model of 1917 was the United States' main battle rifle in World War I. The standard rifle of the United States in 1917 was the Springfield Model 1903 rifle. However, when the United States entered the war, there were not enough Springfield 1903's available for all the new troops, and the U.S. Government owned Springfield Armory couldn't produce them fast enough. Coincidentally, three commercial firearms manufacturers (Winchester, Remington, and Eddystone - a subsidiary of Remington) had just completed a large contract producing Enfield rifles for the British Government. Rather than try to re-tool their factories to produce Springfields, it was quicker and easier to just rechamber the Pattern 1914 Enfield to shoot the .30-06 cartridge. So the U.S. Model of 1917 is basically an Enfield chambered in .30-06.

The match winner today was Gary Thorson shooting a U.S. Model of 1917 Winchester with a score of 294-5X. 2nd place was Damian Longmire shooting a U.S. Rifle Cal. .30 M1 Garand chambered in .308. Damian's score was 281-7X

3rd was Tom Schuettke shooting a U.S. Rifle Cal. .30 M1 for a score of 273-1X

Next we had the Gong Challenge. Winner was Gary Thorson with 9 hits out of 10 shots. Gary was using an AR-10 in .308 caliber.

### MEMBERSHIP DUES RATES

#### Dues and Renewal policies

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees (taxes are additional)**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

**(GUESTS:** Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)

## NOTICE TO ALL HIGH POWER RANGE USERS

Please read and comply with the High Power Range Rules posted on the bulletin board at the High Power Range. In addition, we ask for your cooperation with the following issues that are causing damage to our facilities:

- If you wish to use wooden target stands, please make and bring your own target stands. And take them home with you when you are done shooting.
- You may place your wooden target stands in the target stand bases at the 200 yard line, or make and bring your own target stand base for use at the 50 and 100 yard lines.
- Please **DO NOT** stand the 200 yard target stand bases up on end and staple targets to them or put clay pigeons on them.
- Please **DO NOT** shoot at the 200 yard target stand bases.
- Please **DO NOT** put paper targets or clay pigeons on the gong stand at the 200 yard line. The gong stand is for steel gongs only.
- Please **DO NOT** attach targets to the tires at the 100 yard line, or place targets in front of the tires. The tires are only for hanging your steel gongs at the 100 yard line.

Our High Power Range facilities are maintained by volunteers. When stuff gets shot up or otherwise destroyed, it may be quite a while before it gets repaired.
