- Treasurer's report given by Chris M. No questions on the report. John M. motioned to accept the report as read. Gary T. seconded the motion. Board vote: all "aye".
- Membership report given by John M. currently at 710 members.
- Will U. Gary T. Reid Wall report on High Power Range Project. Demolition occurred yesterday. Trusses ordered and waiting arrival. Waiting on weather, and likely construction start next week. Catch basins that were on original bid (at top of driveway) will be excluded from this project and money will be held back for "cushion" on project. Target completion date tentatively set for the end of February 2019.
- Chris M. have three vendors prepared for walk-through for water filtration/treatment project. Need to schedule.
- Ray C. motioned to approve not-to-exceed \$800.00 to purchase a load of concrete for a project at the Capitol City Bowmen. John M. seconded the motion. Board vote: all "aye". Ray C. also reported the interior (Indoor Range/ Clubhouse) exit/ emergency lights will arrive soon.

- Irene H. Cowboy Action matches/events will be suspended for the winter. Participation is dwindling. Will revisit in the spring. Discussed Women on Target program that was active at CCRP at one time.
- Brian E. read the minutes of this meeting. John M. motioned to accept the meeting minutes as read. Gary T. seconded the motion. Board vote: all "aye".

December Old Soldier Match

Sunday, December 23 was pouring down rain! On the way to the range I was wondering how many Old Soldier shooters don't know enough to come in out of the rain. Turns out there are 6 of us. When I pulled into the parking lot, I asked Damien "Are you sure you want to do this?". Damien replied "But I need 2 more points to make Distinguished!". And then, miraculously, it quit raining. Damien Longmire then proceeded to take 2nd place, and earn 5 more points, to become the final shooter to qualify as a CCR&P Distinguished Rifleman for the 2018 season. CONGRATULATIONS, Damien!

First place in the match went to Gary Thorson shooting a U.S. Model 03A3 Remington for a score of 293-9X out of a possible 300 points.

Second was Damien Longmire, U.S. Rifle Cal. .30 M1 Garand (.308) with a score of 288-5X

Third was Gary Baldwin with an Enfield No. 4 Mk 2 with a score of 274-2X

4th was Rick Baldwin shooting a Swiss K31 for a score of 269-2X

5th is Davis Flowers, Enfield No. 4 Mk 1, 265-5X

6th is Kevin Neubert, U.S. Rifle Cal. .30 M1, 256-3X

These are some pretty nice scores for those old rifles. Just because you are old doesn't mean you can't shoot!

Following the Old Soldier Match, we had our usual gong challenge. We use a 6-inch and an 8-inch gong at 200 yards, and two 8-inch gongs at 100 yards. Each shooter shoots one at a time, taking 2 shots at the gongs. We go through the line 3 times in prone position at 200 yards, then once through the line kneeling at 100 yards, then once through the line standing at 100 yards, for a total of 10 shots. The most hits wins.

Gary Thorson took the pot with a clean sweep of 10 hits out of 10 shots with an AR-10 in .308 Winchester Rick Baldwin scored 8 hits with his AR-15 carbine Kevin Neubert scored 4 hits with his AR-15 service rifle

And Gary Baldwin had 3 hits with a scoped M1A in .308 Winchester

About this time, it started sprinkling again. We decided to skip the .22 silhouette match for the day. One less rifle to clean. And just as everyone was leaving, it started pouring down rain again.

2018 High Power Rifle Champions

Each year we schedule 18 high power rifle matches; 6 Old Soldier matches, 6 NRA / CMP format Service Rifle matches, and 6 M1 Garand matches. Shooters must compete in 5 of the 6 matches to qualify for the season championships. This year, we missed one Old Soldier match due to snow, and we missed one Service Rifle match due to a schedule conflict on the range. So, for the season championships, we took the best 5 M1 Garand scores, and the best 4 Old Soldier and Service Rifle scores to determine the season champions. 2018 CCR&P Distinguished Rifleman Awards

Each year, points are awarded to those competitors who place in your high power rifle matches. The number of points awarded will vary depending on the number of participants in each match. For example, if there are 10+ participants in a match, the top 5 places will earn points; 5 points for 1st place, 4 for 2nd, 3 for 3rd, 2 for 4th, and 1 for 5th. If there are three or less competitors, only the 1st place shooter will earn 1 point. In addition, the top score in each "stage" of a match will earn 1 additional point. When a competitor earns 20 or more points in a calendar year, they are awarded a certificate designating them a CCR&P Distinguished Rifleman for the year.

January 2019 Old West Centerfires 50-70 Match Report Special weather for a special match

Nine shooters were present for this special Old West Centerfires match. Special in that it was set up as an extra match featuring rifles shooting the .50/70 cartridges. Other calibers were also invited and present but preference in final prize awarding was given to the 5070 shooters. As this was almost a mid-winter day, our weather was actually forecast with the of hope of springtime-like temperatures near 50 degrees with calm conditions and just a little rain. At some points the lack of breeze and accumulated black powder smoke made 100-yard targets a very hard to see. The crowd of familiar faces was here which now includes Wesley Davis, Jeff Ritter, Clarence Atchison, and Lynn Willeckie

This match was held on Capitol's black powder Range by event application modification of the permitted firearms rule due to the High Power Range being closed for re-construction. Our course of fire included 20 shots on paper targets with 10 shots on the 100-Yard bullseye, and 10 more shots on the double bullseye buffalo target posted at 50 yards. All shots at paper targets were fired from the sitting position while resting the rifle barrels over cross-sticks. Following the 'paper shooting,' we fired an additional 5 shots at the "bucket" silhouette target which is a reduced-size replica of the "bucket" at the Quigley match in Montana. Like the "bucket" at Quigley, we shot at it from the offhand position with the smaller bucket positioned at 100 yards. One relay, five shots, was fired at "bucket" with the shots fired in sequence as called by the Match director. All nine shooters participated in this event which was won by Bob DeLisle with is .50/70 Hunter's Rifle/Carbine and his paper patched loads with 4 good solid hits, the better score with all others being three hits or less.

Match prizes were awarded for the paper target scores from a selection of club-provided holiday celebration prizes plus merchandise items from C. Sharps Arms and SPG Sales. In recognition of the .50/70 category the top three scores went to those shooting this designated caliber. Mike Nesbitt was first with a score of 180-6X, Lynn Willecke was second with his .50/70 shooting a 160-3X and Bob DeLisle, who was our only shooter using open sights, was third with a 157-3X. From that point on the aggregate awards reverted to "any caliber." So fourth went to Jerry Mayo (who actually had the 2nd highest score) with a 172X, 5th to Clarence Atchison shooting a 138, 6th to Will Ulry with a 102, seventh to Wes Davis with 98X, eighth to Jeff R. Ritter scoring 88 and 9th to Phil Wiebe with 86-3X.

MEMBERSHIP DUES RATES Dues and Renewal policies

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. Membership fees (taxes are additional), collected at the time of the orientation classes are:

Annual dues \$70.00 for the first member of each household and \$35.00 for each

additional eligible member of the household.

Initiation fee (one time) \$80.00 for each household and a refundable gate card deposit

fee of \$10.00 for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually

or recruit two new members or pay an assessment of \$80.00.

Non-immediate family member guests are limited to two visits annually.
