Wednesday Night Indoor .22 Rifle Instructional League

Do you want to practice and improve your rifle shooting during the cold, dark, rainy winter? Well, we have a deal for you.

Every Wednesday evening at 6:30 PM beginning in October and running through the end of March, we will be opening the Indoor Range for .22 rifle shooting. This will be for CCRP Club Members only. The gate will not be locked open, and you will need your key card to get in. There is no charge for this event, and targets will be provided. When we run out of targets, we'll all chip in to buy some more.

This will be a semi-formal shooting session on the Indoor Range, with targets at 50 feet. NRA certified Range Safety Officers will be present to run the line. We usually run four 10-minute firing sessions, with plenty of time between sessions to change targets, chat with your friends, and warm up next to the wood stove. We typically shoot prone, sitting, kneeling, and standing positions. But you can shoot any position you wish.

You can use any .22 rifle you wish; .22 short, long, or long rifle. No magnums, please. Open sights or scope. If you use a semi-auto rifle, please remember that this is target shooting, so no "Mag-dump blasting" will be allowed.

Starting in January, several of the regular shooters will form a team to participate in the National Rifle League postal league competition. You are welcome to join the team, or if you want to just come and shoot for fun, that's fine.

The course of fire for the league is all slow fire, 10 shots in 10 minutes. We shoot four 10-minute stages; prone, sitting, kneeling, and standing. Scores are submitted online to the league web site. There are usually around 35 teams from all over the U.S. and Canada participating in the league.

Come out and join us. It sure beats watching TV.

PSFT December Match

11 hardy souls braved this cold December morning for this month's match. Equipped with rifles, tradeguns and delusions of grandeur, all put forth their best effort in anticipation of snatching up one of the brightly wrapped prizes that jolly Ol' Saint Nick had dropped off with yours truly. The course of fire today for rifles was 25yd paper, 50yd paper (5 shots each) and 5 gongs (50yd, 75yd and 100yd), and for tradeguns, a 25yd paper (5 shots) and 5 gongs (25, 50 and 75yds). Individual match winners for rifle; Bob DeLisle 1st, Mike Nesbitt 2nd and Will Ulry 3rd. Top shooters in the tradegun match were; Jerry Mayo 1st, Mike Nesbitt 2nd and Bob DeLisle 3rd. The top three shooters in the individual matches each received a rather tasty meat prize, which will be long gone before yours truly ever shares a campfire with these scoundrels again. Aggregate rankings (rifle/tradegun scores combined) are; Bob DeLisle 1st 199x, Mike Nesbitt 2nd 198, Will Ulry 3rd 175, Dwayne Anderson 4th 158x, DeWayne Pritchett 5th 157, Steve Andrews 6th 157x (he had a lower tie breaker score), Tom Witt 7th 139, Jerry Mayo 8th 128x, Phil Weibe 9th 112x, Josh Brown 10th 87 and Ralph Birmingham 11th 56. For a little fun we had a "miss and out" match, six deadeyes put in a dollar each and took turns shooting at a 75yd target of my choosing. The ranks were quickly thinned to 4, then 3 and with grim determination in their eyes they slugged it out until 2 remained, Bob DeLisle finally worn his competition down and emerged victorious. Although I doubt his winnings will cover the ball and powder expended. With the brightly wrapped prizes laid out on the table each shooter was called in order to pick out their gift, with squeals of "Oh my!", "Wow!", "Oh boy!" each shooter torn open their prize like kids on Christmas morn A special thanks to Dan Johnson for coming out and helping me keep an eye on things. COVID

Because of Covid, we have some guidelines and goals we would like to work toward:

- It is each individual's responsibility to follow COVID guidelines and protect themselves from communicable diseases.
- If you are sick, please stay home. If you think you are susceptible, consider staying home.
- We want to try to keep one shooting lane separation from each other on the firing line. Household types can buddy up on a table.
- We recommend wearing a face mask if you are in the meeting room.
- Shooters will be self-scoring (and not sharing/touching each other's targets).

Please respond if you intend to shoot some or all of the league so we can map out what attendance will look like.

SCORING/PRIZES

Because of this, this will not be an NRA Sanctioned League this winter, and instead, we will award prizes in two categories: Marksman and Sharpshooter/Expert (combined). Typical rules for an NRA course of fire will be followed (6 – 10 shot relays (2 Slow Fire, 2 Timed, 2 Rapid)).

- For Pistol, it will be your best (5) scores.
- For Revolver, it will be your best (2) scores.

ACCESS

New club rule. The gate is to remain closed during matches. Have your access card handy. If you are a non-member attending, please get ahold of me and we will work out access.

MISC

The first relay is at 6:30pm and the second relay at just before 7:30pm.

Please note, you can shoot either or both relays for score.

The Covid Winter League fee is \$30 (includes sales tax).

Shooters can also pay the fee and shoot for fun, one or two handed.

Come out and shoot for score or just practice. Please forward this email to anyone you think may want to attend.

OLD WEST CENTERFIRES

This crisp Saturday November morning the clouds parted just in time for our final OWC match of 2020. Prizes would be awarded for today's shoot and yearly aggregate prizes would be awarded as well. It was a perfect day it to fire the buffalo guns. Thirteen shooters were present and as always we continue to take the necessary precautions to prevent the spread of Covid-19 virus. Social distancing and appropriate face covering were utilized as dictated by our elected officials. We appreciate Dan Johnson for serving once again as our Range Safety Officer and our thanks go to Tom Brown for managing the match.

The match consisted of the usual ten shots at 100 yards at a single-bullseye target and ten more shots at 200 yards at a larger 200 yard single-bull target. For the yearly aggregate this match's score will be added to the total of previous scores going back to November 2019. Shooters who had already shot in five of our matches this season could throw out their lowest match score and the five remaining match scores are counted

Skip Steinmetz and his son Dan, along with Curt Lokovsek and Ken Kurfurst shot this match in the more common NRA position for BPCR. That's the prone position. The prone position is allowed in our OWC rules, however, we rarely see it used. Mostly you will see shooting from cross-sticks while seated. This is also the position mostly used at the Quigley match. As it turns out the prone shooters turned in some of the highest scores of the day.

A couple of the new BPCR shooters were Jesse James Young and Tom Witt. Jesse's mom was a fan of Old West legends; true story. I had the pleasure of spotting a few shots for Tom and a first time BPCR shooter or not, he is a fine marksman. He posted an 87-x at 100 yards and a 92-2X at 200 yards for a total of 179-2X using a borrowed C. Sharps Arms '74 Hartford in .50/70 caliber. That was shooting a 450 grain bullet over 65 grains of Olde Eynsford (OE) 2F. After posting these very good scores it was only then that Tom realized the Sharps he was using has a set trigger. I can't imagine the scores he'll post when he's not fighting all that trigger pull. Good shooting Tom!

Allen Cunniff submitted targets that were properly witnessed prior to the match. Allen shot a 98-4X at 100 yards and 96 at 200 yards for a total of 194-4X. He was using his favorite '74 CSA Sharps in .45/70 pushing a 550 grain Hoch bullet with 67 grains of Swiss 2F. The match winner was Dan Steinmetz with a winning score of 194-7X. Dan was shooting a Browning Highwall in .40/65 firing a 430 grain Buffalo Arms bullet over 61 grains of Swiss 1½F. Congratulations Dan! The remaining scores for the match are as follows:

Dan Steinmetz had the high scoring target at 100 yards, which we've already seen. Then Ken Kurfurst took the honors for the high scoring target at 200 yards, with a 98-3X. Of course, the scores tumbled down from there. Then at the bottom you see a name that might be familiar. This is definitely the score being discarded for the aggregate. One of those days...

The high shooter for the year is Allen Cunniff with a cumulative score of 947-21X out of the 1000 points possible (five matches at 200 points each). There were other shooters who had earned points for the annual aggregate but they needed to participate in this match in order to be included. Congratulations Allen! For our after-aggregate match we shot at 100- and 200-yard gongs. The order of fire was 5 shots at the steel diamond at 200 yards while sitting behind cross-sticks and 5 more shots at the Quigley style bucket from 100 yards offhand. The 12" diamond represents the 24" diamond at 405 yards on the Quigley range. It's quite a challenge. No less challenging is the offhand bucket at 100 yards representing the 350 yard bucket on the Quigley range that is also shot offhand.

There is only one winner in the after-match and it's winner take all. Curt Lokovsek won with a perfect score, 10 hits for his 10 shots. Ashley Ritter joined us for the after-aggregate match, trying an 1874 Long Range Shiloh in .40-65.

DO NOT SHOOT AT ROCKS

We are continuing to see evidence that people are shooting at rocks on the high power range and the pistol bay. Additionally, people are shooting at the large concrete ecology block next to the culvert at the 100 yard line.

THIS PRACTICE IS ABSOLUTELY UNACCEPTABLE!

Shooting at rocks and concrete WILL cause ricochets. We cannot have bullets ricocheting around or potentially leaving the club property.

READ THE RANGE RULES. You may only shoot at targets authorized in the range rules. All bullets **MUST** impact the berms.

Anyone caught shooting at rocks, concrete, or any other unauthorized targets will be brought before the Board of Directors for disciplinary action.

MEMBERSHIP DUES RATES Dues and Renewal policies

Members will receive a statement 45 days before their membership expires. (Your renewal month is found on your mailing label.) The dues renewal date is the last day of the month in which members' "annual date" falls. Members' gate card will automatically "lock out" on their renewal date if they have not renewed, and their membership will be considered "inactive" for 30-days, during which time they may still pay their dues. After 30-days on "inactive" status the membership will be terminated. Should they wish to rejoin CCR&P past the 30-days "inactive" status, they must reapply as a new member and attend the Orientation class. **Membership fees (taxes are additional)**, collected at the time of the orientation classes are:

Annual dues **\$70.00** for the first member of each household and **\$35.00** for each additional eligible member of the household.

Initiation fee (one time) **\$80.00** for each household and a refundable gate card deposit fee of **\$10.00** for each member.

In addition, each member is expected to devote 8 hours of volunteer service annually or recruit two new members or pay an assessment of **\$80.00**.

NRA membership (required)

Orientation class (required)

(GUESTS: Members may bring their spouses and children under the age of 18 years old **as guests** as often as they'd like. Non-immediate family member guests are limited to two visits annually. Members **MUST** accompany their guests at all times, including spouses and children, and are responsible for the conduct of their guests.)
